**For broadcast applications on established grasses such as fairways and home lawns:** Apply 1.25 fluid ounces of product per 1,000 square feet of turfgrass with spray volumes ranging from 0.5 to 4.0 gallons per 1,000 square feet. Or the equivalent dosage rate is 3.33 to 3.5 pints is product per acre with spray volumes ranging from 22 to 174 gallons per acre.

The maximum application rate is 3.5 pints of product per acre per application [0.75 lb MCPP-p ae per acre per application].
