Do not apply this product through any type of irrigation system. Avoid drift of spray mist to vegetables, flowers, ornamental plants, shrubs, trees and other desirable plants. Do not pour spray solutions near non-target plants. Do not use on warm season grasses, such as St. Augustine, Centipede, Dichondra, or on lawns and turf where desirable clovers are present. NOTE: Coarse sprays are less likely to wind-drift. Do not spray roots of trees and ornamentals. Do not exceed specified dosages for any area; be particularly careful within the dripline of tree and other ornamental species. Do not spray when air temperature exceeds 85 degrees F. Seed can be safely sown 3 to 4 weeks after application. Do not contaminate domestic or irrigation waters. After using this product, clean sprayer thoroughly with soap or detergent and water and rinse thoroughly before applying other pesticides. GENERAL INFORMATION AND INSTRUCTIONS:

DM 896 is a selective herbicide for the control of broadleaf weeds in bluegrass, fescue, bermudagrass, and bentgrass turf. Do not use this product on closely-mowed bentgrass or bermudagrass as on golf greens or tees. Weeds are best controlled when they are young and actively growing.

Weeds Controlled:

Susceptible -- Dandelion, clover, common chickweed, mouse ear chickweed, plantain, pigweed, ragweed and lambsquarter.

Moderately Susceptible -- Knotweed, black medic, English daisy, dock, purslane, oxalis, mallow.

Application Rate:

For established turf, apply 1 oz. to 1-1/4 oz. for 1,000 sqft. (2-2/3 pints to 3-1/3 pints per acre) in 1 to 2 gallons of water per 1,000 sqft. (30 to 60 gallons per acre). Use higher rates when hard-to-kill weeds are present. Maximum control of weeds will be obtained from spring or early fall application when weeds are actively growing. Avoid applying during periods when turf is under stress from drought or extreme heat. Do not water for 24 hours after application. Do not apply to newly seeded turf until after the second or third mowing.

NOTE: Use application equipment that is capable of applying a uniform droplet over the entire area to be covered.
