PRECAUTIONARY STATEMENTS

Hazards to Humans & Domestic Animals:

DANGER: Corrosive. Causes irreversible eye damage. Harmful If swallowed, inhaled or absorbed through the skin. Do not get in eyes, on skin or clothing. When mixing, loading, or applying this product, wear long-sleeved shirt, long pants, socks, shoes, chemical-resistant gloves and eye protection. It is recommended that safety glasses include front, brow and temple protection. STORAGE: Store in original container in a locked storage area. Keep from freezing.

USE PRECAUTIONS: Do not apply this product through any type of irrigation system. Avoid drift of spray mist to vegetables, flowers, ornamental plants, shrubs, trees and other desirable plants. Do not pour spray solutions near non-target plants. Do not use on warm season grasses, such as St. Augustinegrass, centipedegrass, dichondra, or on lawns and turf where desirable clovers are present. NOTE: Coarse sprays are less likely to wind-drift. Do not spray roots of trees and ornamentals. GENERAL INFORMATION AND INSTRUCTIONS: DM 896 is a selective herbicide for the control of broadleaf weeds in bluegrass, fescue, bermudagrass, and bentgrass turf. Do not use this product on closely-mowed bentgrass or bermudagrass as on gc. greens or tees. Weeds are best controlled when they are young and actively growing.

Weeds Controlled:

<u>Susceptible</u> -- dandelion, clover, common chickweed, mouseear chickweed, plantain, pigweed, ragweed and lambsquarter.

Moderately Susceptible -- knotweed, black medic, English daisy, dock, purslane, oxalis, mallow.

Application Rate: For established turf, apply 1 to 1 1/4 fluid ounces for 1,000 square feet (2 2/2 pints to 3 1/3 pints per acre) in 1 to 2 gallons of water per 1,000 square feet (30 to 60 gallons per acre). Use higher rates when hard-to-kill weeds are present. Maximum control of weeds will be obtained from spring or early fall applications when weeds are actively growing. Avoid applying during periods when turf is under stress from drought or extreme heat. Do not water for 24 hours after application. Do not apply to newly seeded turf until after the second or third mowing.

The maximum application rate to turf is 0.9 pounds 2,4-D acid equivalent per acre per application per site. The maximum number of broadcast applications per treatment site is 2 per year.

NOTE: Use application equipment that is capable of applying uniform droplets over the entire area to be covered.
