Do not use this product on closely-mowed bentgrass or bermudagrass as on golf greens or tees. Weeds are best controlled when they are young and actively growing.

Weeds Controlled:

<u>Susceptible</u> - dandelion, clover, common chickweed, mouseear chickweed, plantain, pigweed, ragweed and lambsquarter.

Moderately Susceptible -- knotweed, black medic, English daisy, dock, pursiane, oxalis, mallow.

Application Rate: For established turf, apply 1 to 1 1/4 fluid ounces for 1,000 square feet (2 2/3 pints to 3 1/3 pints per acre) in 1 to 2 gallons of water per 1,00C square feet (30 to 60 gallons per acre). Use higher rates when hard-to-kill weeds are present. Maximum control of weeds will be obtained from spring or early fall application when weeds are actively growing. Avoid applying during periods when turf is under stress from drought or extreme heat. Do not water for 24 hours after application. Do not apply to newly seeded turf until after the second or third mowing.
