- 1) Submit and/or cite all data required for registration/reregistration review of your product when the Agency requires all registrants of similar products to submit data.
- 2) Per the acute toxicity review, the Hazards to Humans and Domestic Animals must be revised to include the following text:

"Harmful if inhaled. Avoid contact with skin. Avoid breathing spray mist or vapor."

- 3) Under the Personal Protective Equipment section, add the text "(PPE)" immediately following the section heading. In addition, due to the acute toxicity review, revise the glove statement "chemical-resistant gloves (except for applicators using ground boom equipment)" to read "chemical-resistant gloves."
- 4) User Safety Recommendations must be added to the label as follows:

"User Safety Recommendations

User should wash hands before, eating, drinking, chewing gum, tobacco, of using the toilet.

User should remove clothing/PPE immediately if pesticide gets inside. Then wash thoroughly and put on clean clothing. If pesticide gets on skin, wash immediately with soap and water.

Users should remove PPE immediately after handling this product. As soon as possible, wash thoroughly and change into clean clothing."

5) With the exception of drift-related text appearing in the Environmental Hazards ("Drift and runoff may be hazardous to aquatic organisms in water adjacent to treated areas") and General Precautions and Restrictions ("Do not apply this product in a way that will contact workers or other persons, either directly or through drift"), all drift text appearing on the label must be placed together and be located below the following required text. Any conflicting text must be deleted from the label.

Spray drift text must be added to the label and should read:

"Spray Drift Management

A variety of factors including weather conditions (e.g., wind directions, wind speed, temperature, relative humidity) and method of ground application can influence pesticide drift. The applicator must evaluate all factors and make appropriate adjustments when applying this product.

#### **Droplet Size**

Use a medium or coarser spray nozzles according to (ASAE standard 572) definition of standard nozzles or a volume mean diameter of 300 microns or greater for spinning atomizer nozzles.

#### Wind Speed

Do not apply at wind speeds greater than 10 mph. Only apply this product if the wind direction favors on-target deposition and there are not sensitive areas (including, but not limited to, residential areas, bodies of water, known habitat for nontarget species, nontarget crops) within 250 feet downwind.

#### **Temperature Inversions**

If applying at wind speeds less than 3 mph, the applicator must determine if: a) conditions of

temperature inversion exist, or b) stable atmospheric conditions exist at or below nozzle height. Do not make applications into areas of temperature inversions or stable atmospheric conditions.

#### **Susceptible Plants**

Do not apply under circumstances where spray drift may occur to food, forage, or other plantings that might be damaged or crops thereof rendered unfit for sale, use or consumption. Susceptible crops include, but are not limited to, cotton, okra, flowers, grapes (in growing stage), fruit trees (foliage), soybeans (vegetative stage), ornamentals, sunflowers, tomatoes, beans, and other vegetables, or tobacco. Small amounts of spray drift that might not be visible may injure susceptible broadleaf plants.

#### Other State and Local Requirements

Applicators must follow all state and local pesticide drift requirements regarding application of 2,4-D herbicides. Where states have more stringent regulations, they must be observed.

#### **Equipment**

All ground application equipment must be properly maintained and calibrated using appropriate carriers or surrogates.

#### For ground boom application:

Do not apply with a nozzle height greater than 4 feet above the crop canopy."

6) Under the Limitations on Spot Treatments for Ornamental Turfgrass section, (due to the presence of MCPP-p) add the following statements:

"Limited to 2 applications per year. Minimum of 30 days between applications."

7) On page 2 change "For use on residential and other turf sites excluding sod farms" to "For use on residential and other ornamental turf sites excluding sod farms".

Submit one copy of the revised final printed label for the record. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions. A stamped copy of the label is enclosed for your records. #### **Hazards to Humans and Domestic Animals**

#### **Environmental Hazards**

This pesticide may be toxic to fish and aquatic invertebrates and may adversely affect non-target plants. Do not apply directly to water, to areas where surface water is present, or to intertidal areas below the mean high water mark. Drift and runoff may be hazardous to aquatic organisms in water adjacent to treated areas. Do not contaminate water when disposing of equipment wash waters or rinsate.

# **DIRECTIONS FOR USE**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

General Precautions and Restrictions:

- Do not enter or allow people (or pets) to enter the treated area until sprays have dried.
- Do not apply this product in a way that will contact workers or other persons, either directly or through drift. Only protected handlers may be in the area during application.

FOR USE ON RESIDENTIAL AND OTHER TURF SITES EXCLUDING SOD FARMS.

#### **USE PRECAUTIONS:**

Do not apply this product through any type of irrigation system. Do not use on warm season grasses, such as St. Augustinegrass, centipedegrass, dichondra, or on lawns and turf where desirable clovers are present. Do not exceed specified dosages for any area. Do not broadcast apply when air temperatures exceed 85°F; some injury may be expected with spot treatments when air temperatures exceed 85°F. Seed can be sown 3 to 4 weeks after application.

#### INSTRUCTIONS:

DM 896 is a selective herbicide for the control of broadleaf weeds in bluegrass, fescue, bermudagrass, and bentgrass turf. Do not use this product on closely-mowed bentgrass or bermudagrass as on golf greens or tees. Weeds are best controlled when they are young and actively growing.

#### **WEEDS CONTROLLED:**

**Susceptible --** dandelion, clover, common chickweed, mouseear chickweed, plantain, pigweed, ragweed and lambsquarters.

Moderately Susceptible -- knotweed, black medic, English daisy, dock, purslane, oxalis, mallow

#### **APPLICATION RATE:**

For established turf, apply 1 to 1.25 fluid ounces for 1,000 square feet (2 2/3 pints to 3 1/3 pints per acre) in 1 to 2 gallons of water per 1,000 square feet (40 to 80 gallons per acre). Use higher rates when hard-to-kill weeds are present. Maximum control of weeds will be obtained from spring or early fall applications when weeds are actively growing. Avoid applying during periods when turf is under stress from drought or extreme heat. Do not water for 24 hours after application. Do not apply to newly seeded turf until after the second or third mowing.

#### Other Use Precautions:

 Do not use this product on or near desirable plants, including contact of spray on exposed root systems or adventitious shoots within the drip line of desirable trees and shrubs, since injury may result.

#### Limitations on broadcast treatments for ornamental turfgrass:

The maximum application rate is 3.33 pints of product per acre per application (0.78 lbs 2,4-D ae and 0.41 lb MCPP-p ae per acre per application). The maximum number of broadcast applications is limited to 2 per year with a minimum of 30 days between applications. The maximum seasonal rate is 6.67 pints of product per acre (1.58 lbs 2,4-D ae and 0.83 lb MCPP-p ae per acre).

#### Limitations on spot treatments for ornamental turfgrass:

Spot treatment is defined as a treatment area no greater than 1,000 sq.ft. per acre. The maximum application rate is 1.25 fl.oz. per 1,000 sq.ft. per application (0.41 lbs MCPP-p acid equivalent per acre).

#### STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

**PESTICIDE STORAGE:** Store in original container in a locked storage area. Keep from freezing.

**PESTICIDE DISPOSAL:** Pesticide wastes are toxic. Improper disposal of excess pesticide, spray mixture, or rinsate is a violation of Federal law and may contaminate groundwater.
