

3. Make the following additional revisions to the final printed labeling:
  - a. The following revisions are needed to the handler PPE section:
    - Per the acute toxicity review, gloves are required for all handlers; therefore, the text "when mixing, loading, or using any hand-held equipment" appearing in the handler glove statement must be deleted.
    - Replace "Protective eyewear (goggles, face shield, or safety glasses)" with "Goggles or face shield." As this product is an acute toxicity category I for primary eye, this PPE should be listed first.

- b. The First Aid heading, "If on skin" must be revised to read: "If on skin or clothing."
- c. The first sentence of the Environmental Hazard section must be revised to read: "This pesticide may adversely affect non-target plants." The text "This pesticide may be toxic to fish, aquatic invertebrates and aquatic plants" is no longer required and may be removed from the label.
- d. Per the MCPPP-p RED, the retreatment interval for broadcast and spot treatment must be revised to 30 days. (see pg. 4 of the label)
- e. Per the MCPPP-p RED, the following text must be added to the spray drift section after the 'Wind Speed' paragraph:

**"Temperature Inversions**

If applying at wind speeds less than 3 mph, the applicator must determine if 1) conditions of temperature inversion exist, or 2) stable atmospheric conditions exist at or below nozzle height. Do not make applications into areas of temperature inversions or stable atmospheric conditions."

- 4. Submit one (1) copy of the revised final printed label for the record before you release the product for shipment. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

**GENERAL INFORMATION:**

Trimec® 959 Broadleaf Herbicide provides selective broadleaf control in warm season and cool season turfgrass. Established turf of warm season grasses include, but are not limited to, bermudagrass, bahiagrass, and zoysiagrass. Established turf of cool season grasses include, but are not limited to, Kentucky bluegrass, perennial ryegrass, tall fescue, and turf-type tall fescues. Do not apply this product on carpetgrass, dichondra or established turf containing desirable clovers.

**USE PRECAUTIONS - OBSERVE CAREFULLY.**

1. Do not pour spray solutions near these plants.
2. Do not spray on carpetgrass, dichondra nor on lawns or turf where desirable clovers are present.
3. Use only lawn type sprayers.
4. Avoid application to exposed active feeder roots of shallow-rooted trees such as poplar species and sensitive ornamentals. Do not exceed specified dosages for any area.

5. Do not use this product on or near desirable plants, including contact of spray on exposed root systems or adventitious shoots within the drip line of desirable trees and shrubs, since injury may result.
6. Do not spray bermudagrass or zoysiagrass while emerging from dormancy, unless injury can be tolerated.
7. Applications to newly seeded lawns may cause injury. Delay application until well established or after two or three mowings.
8. Do not broadcast apply when air temperatures exceed 85°F; some injury may be expected with spot treatments when air temperatures exceed 85°F.
9. Seed can be sown 3 to 4 weeks after application.
10. Do not contaminate domestic or irrigation waters.
11. Some injury can be expected to turf when used on centipedegrass or St. Augustinegrass; only spot spray weeds on these types of grasses. Clover will be damaged if sprayed.
12. After using this product, clean sprayer with soap or detergent and water, and rinse thoroughly before applying other pesticides.
13. Failure to observe the above precautions may result in injury to desirable plants.
14. Do not apply this product through any type of irrigation system.

**ORNAMENTAL LAWNS, ORNAMENTAL TURFGRASS, GOLF COURSES AND SOD FARMS - As Broadcast Treatments:**

Apply 3.0 to 4.0 pints of product per acre per application with spray volumes of 20 to 240 gallons per acre. Maximum control of weeds will be obtained from spring or early fall applications when weeds are actively growing. Avoid applying during long excessively dry or hot periods unless adequate irrigation is available. Do not apply to newly seeded turf until well-established or after the second or third mowing. Grass seed can be sown 3 to 4 weeks after application at the recommended rates.

**Limitations on broadcast treatments for turfgrass on all use sites:**

The maximum application rate is 4.0 pints of product per acre per application (1.49 lbs MCPA ae, 0.32 lb MCPP-p ae, and 0.15 lb dicamba ae per acre per application). The maximum number of broadcast applications is limited to 2 per year with a minimum of 21 days between applications. The maximum seasonal rate is 8.0 pints of product per acre per year (2.97 lb MCPA ae, 0.63 lb MCPP-p ae, and 0.29 lb dicamba ae per acre per year), excluding spot treatments.

**Limitations on spot treatments for all use sites:**

Spot treatment is defined as a treatment area no greater than 1,000 sq.ft. per acre. The maximum application rate is 1.5 fl.oz. per 1,000 sq.ft. per application (0.32 lb MCPP-p acid equivalent per acre). The maximum number of spot treatments is limited to 2 per year with a minimum of 21 days between applications.

**BENTGRASS TURF:**

In closely-mowed bentgrass (putting and bowling greens) apply at a maximum rate of 1 fluid ounce of product per 1,500 square feet, preferably in May or mid-August through September. Slight turf yellowing will disappear after about one week.

NOTE: Care should be taken to avoid overdosing bentgrass or injury may result. High spray volumes (i.e., 1 fluid ounce of product in 5 gallons of water per 1,500 square feet) will aid in obtaining uniform coverage. If hand-operated sprayers are used, it is preferable to use a single nozzle sprayer rather than a multiple nozzle boom. Sweeping movements with a multiple nozzle boom will result in heavy local over-application and subsequent turf discoloration or injury.

**SPRAY DRIFT MANAGEMENT**

Avoiding spray drift at the application site is the responsibility of the applicator. The interaction of many equipment-and weather-related factors determine the potential for spray drift. The applicator and the grower are responsible for considering all these factors when making decisions.

Apply only as a medium or coarser spray (ASAE standard 572) or a volume mean diameter of 300 microns or greater for spinning atomizer nozzles.

**Wind Speed**

Apply only when the wind speed is 2 to 10 mph at the application site. Do not apply at wind speeds greater than 10 mph.

**Additional requirements for ground boom application:**

Do not apply with a nozzle height greater than 4 feet above the crop canopy.
