Gordon's Granular 33½ (EPA Reg. No. 2217-794)

I. Labeling notification per Pesticide Registration Notice (PRN) 2007-4:

- 1. We ask to revise the disposal instructions and to adopt the exact language of Pesticide Registration Notice (PRN) 2007-4, Labeling Revisions Required by the Final Rule "Pesticide Management and Disposal: Standards for Pesticide Containers and Containment." One (1) copy of the annotated labeling is enclosed for your review. Please refer to page 5 of the draft labeling.
- 2. Certification: This notification is consistent with the guidance of PR Notice 2007-4 and the requirements of EPA's regulations at 40 CFR 156.10, 156.140, 156.144, 156.146, and 156.156. No other changes have been made to the labeling or the confidential statement of formula of this product. I understand that it is a violation of 18 U.S.C. Sec. 1001 to willfully make any false statement to the EPA. I further understand that if this amended labeling is not consistent with the terms of 40 CFR 156.10, 156.140, 156.144, 156.146, and 156.156, this product may be in violation of FIFRA and I may be subject to enforcement action and penalties under Section 12 and 14 of FIFRA.

II. Labeling notification for Pesticide Registration Notice (PRN) 2008-1

1. We ask to revise the environmental hazards section of the labeling and to adopt the exact language of Pesticide Registration Notice (PRN) 2008-1, Environmental Hazard Labeling Statements on Outdoor Residential Use. Please refer to page 2 of the draft labeling.

2. Certification: This notification is consistent with the guidance PR Notice 2008-1 and the requirements of EPA's regulations at 40 CFR 156.10, 156.80, and 40 CFR152.46, and no other changes have been made to the labeling or the confidential statement of formula of this product. I understand that it is a violation of 18 U.S.C.Sec. 1001 to willfully make any false statement to the EPA. I further understand that if this notification is not consistent with the guidance of PRN 2008-1 and the requirements of 40 CFR 156.10, 40 CFR 156.80, and 40 CFR 152.46, this product may be in violation of FIFRA and I may be subject to enforcement action and penalties under Section 12 and 14 of FIFRA.

III. Labeling notification per PRN 98-10:

- 1. We ask to add the instructions for an improved distribution pattern using centrifugal and drop spreaders. These instructions are consistent with use directions previously approved. Also, advertising claims are requested. Please refer to the Appendix, page 7 of the draft labeling.
- 2. Certification: This notification is consistent with the provisions of PR Notice 98-10 and EPA regulations at 40 CFR 152.46, and no other changes have been made to the labeling or the confidential statement of formula of this product. I understand that it is a violation of 18 U.S.C. Sec. 1001 to willfully make any false statement to the EPA. I further understand that if this notification is not consistent with the terms of PR_Notice 98-10 and 40 CFR 152.46, this product may be in violation of FIFRA and I may be subject to enforcement action and penalties under Section 12 and 14 of FIFRA.

- . Do not enter or allow people (or pets) to enter the treated area until dusts have settled.
- Do not apply this product in a way that will contact workers or other persons, either directly or through drift. Only protected handlers may be in the area during application.
- For use on ornamental lawns and turf established in institutional, ornamental, and residential sites.
- Grass seed crops and sod farm uses are excluded.
- Not for use on turf being grown for sale or other commercial use as sod, or for commercial seed production, or for research purposes.

WHERE TO USE:

Gordon's Granular 33½ is a Trimec® herbicide containing fertilizer, 2,4-D, mecoprop-p, and dicamba. This granular weed and feed provides plant nutrients and controls a broad spectrum of broadleaf weeds in turfgrass. Supplemental nitrogen, phosphorus, and potash should be applied according to soil tests or State Extension Service recommendations.

Gordon's Granular 33½ is intended to be applied by noncommercial users, lawn care operators, and landscape personnel. Cool season grasses established in institutional, ornamental, and residential sites may be treated.

Institutional sites are defined as turf areas around properties or facilities providing a service to public or private organizations; for example areas around hospitals, nursing homes, schools, museums, libraries, sport facilities (including golf courses), and office buildings may be treated. Ornamental sites include turfgrass established around residences, parks, streets, retail outlets, cemeteries, and institutional buildings. Finally, residential sites are defined as areas associated with the household or home life including, but not limited to apartment complexes, condominiums, and patient care areas of nursing homes, mental institutions, hospitals, or convalescent homes.

Gordon's Granular 33½ may be applied to newly seeded cool season turfgrass. Applications are recommended only after the third mowing or after the grass seedlings have tillered and have developed an adequate secondary root system.

A uniform broadcast distribution of product on the treated area is essential. Do not exceed the specified application rate for any area. Do not use this product on or near desirable plants, and avoid spreading granules onto exposed root systems or adventitious shoots (rhizomes) within the drip line of desirable trees and shrubs, since injury may result.

Do not use this product on dichondra, carpetgrass, St. Augustinegrass, closely-mowed bentgrass putting greens, or turf containing desirable clovers.

WEEDS CONTROLLED:

Dandelion, chickweed, plantain, and clover are controlled effectively with Gordon's Granular 33½. A partial list of susceptible weeds is shown below:

HOW MUCH TO APPLY:

Apply 140.5 to 158.4 pounds (lb) of Gordon's Granular 33½ per acre of established turfgrass. Or the equivalent application rate is 3.23 to 3.64 pounds of product per 1,000 square feet (sq.ft.) of turfgrass.

The maximum broadcast application rate is 3.64 pounds of product per 1,000 sq.ft. per application (1.2 lb 2,4-D ae, 0.27 lb MCPP-p ae and 0.11 lb dicamba ae per acre per application). The maximum number of broadcast applications is limited to 2 per year with a minimum of 30 days between applications. The maximum seasonal rate is 7.28 pounds of product per 1,000 sq.ft. (2.4 lb 2,4-D ae, 0.54 lb MCPP-p ae and 0.22 lb dicamba ae per acre).

A sequential or follow-up application may be required for dense infestations of perennial and biennial weeds. Also, adverse environmental conditions prior or after application may reduce the effectiveness. If required, the treatment interval between the first and second applications should be approximately 30 days.

Drop spreaders, rotary spreaders, and other granular equipment should be calibrated for accurate and uniform applications of this product. Calibrate the equipment by applying the product over a measured or known area and adjust the equipment according to the recommendations of the equipment manufacturer. Refer to the rate table for the appropriate bag sizes and the area to be treated.

Optional: Equipment settings of drop spreaders, rotary spreaders, and other granular applicators may be presented on the container labels as requested by supplemental registrants.

APPLICATION SUGGESTIONS:

- 1. Spring and fall applications are recommended for the best control. However, Gordon's Granular 33½ can be applied any time broadleaf weeds are present and actively growing.
- 2. Mow the turfgrass 2 to 3 days before application.
- 3. Water the turfgrass thoroughly (>1/2 inch) at least 1 to 2 days before application.
- 4. Schedule applications in the morning when dew is present. Or sprinkle or irrigate lightly (<1/4 inch) before application to provide maximum control.
- 5. Rainfall or irrigation within 24 hours after application may reduce the effectiveness. Do not irrigate or water the turfgrass within 24 hours after application.
