On the basis of information furnished by the registrant, the above named pesticide is hereby registered/reregistered under the Federal Insecticide, Fungicide and Rodenticide Act.

In order to protect health and the environment, the Administrator, on his motion, may at any time suspend or cancel the registration of a pesticide in accordance with the Act. The acceptance of any name in connection with the registration of a product. This product is conditionally registered in accordance with FIFRA sec. 3(c)(7)(A) provided that you:

- 1. Submit and/or cite all data required for registration of your product under FIFRA sec. 3(c)(5) when the Agency requires all registrants of similar products to submit such data; and submit acceptable responses required for reregistration of your product under FIFRA section 4.
- 2. Make the following label changes before you release the product for shipment:
 - a. Revise the EPA Registration Number to read "EPA Reg. No. 2217-814".
 - b. Revise the last two sentences of the paragraph under "Hazards to Human and Domestic Animals" to read as required by the 1992 2,4-D Exposure Reduction Agreement.

"After using this product, rinse gloves before removing, remove clothing and launder separately before reuse, and promptly and thoroughly wash hands and exposed skin with soap and water. Remove saturated clothing as soon as possible and shower."

c. Revise the second sentence of the oral ("If Swallowed") statement of practical treatment as recommended in the Agency's recently revised (12/96) Label Review Manual:

"Do not induce vomiting or give anything by mouth to an unconcious person."

d. Add a statement to the front panel, immediately below the product name, prohibiting use of the product by homeowners. This statement is being required because the product is labeled for use on turf sites, including residential sites, and is classified in Toxicity Category I (Danger) based on eye irritation potential. The following statement is recommended:

"Use of this product on residential and other turf sites is limited to commercial applicators and other professional lawn care operators and maintenance personnel. Not for sale to or use by homeowners."

3. Submit one copy of the revised final printed label for the record before you release the product for shipment.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

A stamped copy of the label is enclosed for your records. A copy of the Agency's review of product chemistry data submitted to support this registration is also enclosed.

PRECAUTIONARY STATEMENTS

Hazards to Human and Domestic Animals

DANGER: Corrosive. Causes irreversible eye damage. Harmful if swallowed, inhaled, or absorbed through the skin. Do not get in eyes or on clothing. When using this product, wear long-sleeved shirt, long pants, socks, shoes, chemical resistant gloves and eye protection. It is recommended that safety glasses include front, brow, and temple protection. Avoid breathing dust. Avoid contact with skin. Prolonged or frequently repeated skin contact may cause allergic reactions in some individuals. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash clothing before reuse.

Statement of Practical Treatment

IF IN EYES: Hold eyelids open and flush with a steady, gentle stream of water for at least 15 minutes. Get medical attention.

IF SWALLOWED: Call a doctor or get medical attention. Do not induce vomiting. Drink promptly a large quantity of milk, egg whites, gelatin solution, or if these are not available, drink large quantities of water. Avoid alcohol.

IF INHALED: Remove victim to fresh air. If not breathing give artificial respiration, preferably mouth-to-mouth. Get medical attention.

IF ON SKIN: Wash skin with plenty of soap and water. Get medical attention.

NOTE TO PHYSICIAN: Probable mucosal damage may contraindicate the use of gastric lavage.

ENVIRONMENTAL HAZARDS: This product is toxic to aquatic invertebrates. Drift or runoff may adversely affect aquatic invertebrates and nontarget plants. Do not apply directly to water, or to areas where surface water is present, or to intertidal areas below the mean high water mark. Do not contaminate water when disposing of equipment washwaters. When cleaning equipment, do not pour the washwater on the ground; spray or drain over a large area away from wells and other water sources.

Most cases of groundwater contamination involving phenoxy herbicides such as 2,4-D and MCPP have been associated with mixing/loading and disposal sites. Caution should be exercised when handling 2,4-D and MCPP pesticides at such sites to prevent contamination of groundwater supplies. Use of closed systems for mixing or transferring this pesticide will reduce the probability of spills. Placement of the mixing/loading equipment on an impervious pad to contain spills will help prevent groundwater contamination.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Do not allow people (other than applicator) or pets on treatment area during application. Do not enter treatment area until spray has dried. Not for use on turf being grown for sale or other commercial use as sod, or for commercial seed production, or for research purposes.

STORAGE & DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

STORAGE: Store in original container. To prevent cross-contamination, do not store near other pesticides, fertilizers, food, feed, or seeds.

PESTICIDE DISPOSAL: Pesticide wastes are toxic. Improper disposal of excess pesticide, spray mixture, or rinsate is a violation of Federal law and may contaminate groundwater. If these wastes cannot be disposed of by use according to label instructions contact your State Pesticide or Environmental Control Agency, or the Hazardous Waste representative at the nearest EPA Regional Office for guidance.

CONTAINER DISPOSAL: Completely empty bag into application equipment. Then dispose of empty bag in a sanitary landfill, or by incineration, or if allowed by State and local authorities by burning. If burned stay out of smoke.

SITES:

EH1314 Herbicide is intended to be applied by lawn care operators, maintenance applicators, and service technicians for use in ornamental lawns and turf established in ornamental sites. Residential and institutional sites include turfgrass established around residences, parks, streets, retail outlets, cemeteries, industrial and institutional buildings. Cool season turfgrass species include Kentucky bluegrass, perennial ryegrass, and the fescues. Warm season turfgrass species include bermudagrass and zoysiagrass.

MIXING INSTRUCTIONS WITH WATER AS THE CARRIER:

- 1. Fill the spray tank with ½ to ¾ of the required amount of water and begin agitation. Sufficient agitation during mixing and application is essential.
- 2. Add EH1314 Herbicide into the spray tank and maintain continuous agitation to avoid separation.
- 3. Fill the spray tank to % of the required amount of water. If tank mixtures are being prepared, add the companion product when the spray tank is approximately % full.
- 4. Finally, add the balance of the required water volume and maintain agitation prior to and during the application.

APPLICATION RATES FOR ORNAMENTAL TURFGRASS:

For Kentucky bluegrass, Fescue spp., Perennial Ryegrass, Bermudagrass and Zoysiagrass - Apply 2.20 - 3.30 pounds of product per acre per application with spray volumes ranging from 20 to 220 gallons per acre. The maximum application rate to established turfgrass is 1.50 pounds 2,4-D acid equivalent per acre per application per site. The maximum number of broadcast applications per treatment site is two applications per year. The maximum application rates are presented below:

USE PRECAUTIONS:

Do not apply this product through any type of irrigation system. Avoid drift of spray mist to vegetables, flowers, ornamentals, shrubs, trees, and other desirable plants. Do not pour spray solutions near these plants. Do not spray on carpetgrass, dichondra, nor on lawns or turf where desirable clovers are present.

Coarse sprays are less likely to wind drift. Do not spray roots of ornamentals and trees. Do not exceed specified dosages for any area. Be particularly careful within the dripline of trees and other ornamental species. Do not apply to newly seeded grasses until well established. Do not broadcast apply when air temperatures exceed 85°F; some injury may be expected with spot treatments when air temperatures exceed 85°F. Seed can be sown 3 to 4 weeks after application at recommended rates.
