Subject: EPA Reg. 2217-833 Speed Zone Broadleaf Herbicide / 2,4-D RED amendment

The labeling referred to above is in compliance with the 2,4-D RED provided that you:

- 1) Submit and/or cite all data required for registration/reregistration review of your product when the Agency requires all registrants of similar products to submit data.
- 2) Please note: Final product reregistration can't be considered until after all active ingredients in this product are eligible for reregistration.
- 3) The heading "IF ON SKIN" appearing in the First Aid statements must be revised to read "IF ON SKIN OR CLOTHING."
- 4) Per the acute toxicity review, child resistant packaging is triggered for this product.
- 5) The following revisions are needed to the handler PPE section:
- -"Flaggers" must be deleted from the PPE text "All mixers, loaders, applicators, flaggers, and other handlers," because aerial application is not allowed for products that contain MCPP-p.
- -The glove statement currently on the label ("chemical-resistant gloves when applying with any handheld nozzle or equipment, mixing or loading, cleaning up spills or equipment, or otherwise exposed to the concentrate") must be revised to read "chemical-resistant gloves," because the acute toxicity review specifies chemical-resistant gloves for all handlers.
- 6) The mechanical transfer engineering control text is no longer needed and may be deleted from the label.
- 7) Per the 2,4-D, Dicamba and MCPP-p REDs, the first 2 sentences in the first paragraph of the Environmental Hazards section must be revised to read:
- "This pesticide is toxic to fish and aquatic invertebrates and may adversely affect non-target plants. Do not apply directly to water, to areas where surface water is present, or to intertidal areas below the mean high water mark."
- 8) Per the MCPP-p RED, the REI must be revised from 24 to 48 hours.

Per the Dicamba RED, the early entry PPE must be revised to read:

"Coveralls worn over short-sleeve shirt and short pants, Chemical-resistant footwear plus socks, Page 2 EPA Reg. 2217-833

Chemical-resistant gloves made of any waterproof material, Chemical-resistant headgear for overhead exposure, Protective eyewear."

- 9) Per the product chemistry review, the heading "Storage" should be revised to read "Pesticide Storage" in the Storage and Disposal section of the label.
- 10) Per the 2,4-D, Dicamba and MCPP-p REDs, the spray drift text currently on the draft label must be revised to read:

# "Spray Drift Management

A variety of factors including weather conditions (e.g., wind directions, wind speed, temperature, relative humidity) and method of ground application can influence pesticide drift. The applicator must evaluate all factors and make appropriate adjustments when applying this product.

# **Droplet Size**

Use a medium or coarser spray nozzles according to (ASAE standard 572) definition of standard nozzles or a volume mean diameter of 300 microns or greater for spinning atomizer nozzles.

# Wind Speed

Do not apply at wind speeds greater than 10 mph. Only apply this product if the wind direction favors on-target deposition and there are not sensitive areas (including, but not limited to, residential areas, bodies of water, known habitat for nontarget species, nontarget crops) within 250 feet downwind.

# **Temperature Inversions**

If applying at wind speeds less than 3 mph, the applicator must determine if: a) conditions of temperature inversion exist, or b) stable atmospheric conditions exist at or below nozzle height. Do not make applications into areas of temperature inversions or stable atmospheric conditions.

# Susceptible Plants

Do not apply under circumstances where spray drift may occur to food, forage, or other plantings that might be damaged or crops thereof rendered unfit for sale, use or consumption. Susceptible crops include, but are not limited to, cotton, okra, flowers, grapes (in growing stage), fruit trees (foliage), soybeans (vegetative stage), ornamentals, sunflowers, tomatoes, beans, and other vegetables, or tobacco. Small amounts of spray drift that might not be visible may injure susceptible broadleaf plants.

# Other State and Local Requirements

Applicators must follow all state and local pesticide drift requirements regarding application of 2,4-D herbicides. Where states have more stringent regulations, they must be observed.

## **Equipment**

All ground application equipment must be properly maintained and calibrated using appropriate carriers or surrogates.

Do not apply with a nozzle height greater than 4 feet above the crop canopy.

2,-4-D esters may volatilize during conditions of low humidity and high temperatures. Do not apply during



conditions of low humidity and high temperatures."

- 11) Per the MCPP-p RED, the retreatment interval for ornamental turfgrass ("the retreatment interval for sequential broadcast applications of this product on ornamental turfgrass is two (2) to six (6) weeks depending upon the growth stages of the target weeds") appearing on the bottom of Page 8 of the label must be revised to be at least 30 days.
- 12) On page 8, change "rate recommendations" to "rates".
- 13) To the label add "Do not apply more than two applications per year, including broadcast applications in combination with spot treatments".
- 14) To the Warranty section add "to the extent consistent with applicable law" in front of "the exclusive remedy".
- 15) To the label add "Use of this product in certain portions of California, Oregon, and Washington is subject to the January 22, 2004 Order for injunctive relief in <u>Washington Toxics Coalition</u>, et. al. v. Submit one copy of the revised final printed label for the record. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). PRODUCT DESCRIPTION: Speed Zone Broadleaf Herbicide contains four active ingredients including carfentrazone-ethyl that broaden the spectrum of weed control. Carfentrazone-ethyl is in the aryl.

triazolinone family and inhibits protoporphyrinogen oxidase (Protox), a pivotal enzyme in chlorophyll production.

Speed Zone Broadleaf Herbicide offers these advantages:

- Excellent postemergent activity with proven performance for broadleaf weed control in turfgrass.
- Superior cool weather performance.
- High selectivity (turfgrass safety) in established cool season turfgrass and warm season turfgrass.
- Good toxicological, environmental, and ecological properties compared to the standards.
- Carfentrazone-ethyl combinations provide rapid and effective weed control for common and troublesome weed species in turfgrass, e.g. spurge, pennywort (dollarweed), dandelion, and white clover.
- Fast acting with evidence of injury within hours. The speed of action (rate of phytotoxicity) and the early injury symptoms are unique features of carfentrazone-ethyl combinations. Generally, the injury symptoms can be noticed within hours of the application and plant death can occur within 7 14 days.

#### SPRAY PREPARATION AND TANK MIXTURES:

Speed Zone Broadleaf Herbicide is an emulsifiable concentrate intended for dilution with water. In certain applications, liquid fertilizer may replace part of the water in the mixture.

#### Mixing with Water:

Add one-half the required amount of water to the spray tank, then add Speed Zone Broadleaf Herbicide slowly with agitation, and complete filling the tank with water. To prevent separation of the emulsion, mix thoroughly and continue agitation while spraying.

This product forms an emulsion and can separate upon extended or prolonged standing. Re-agitate to assure uniformity of the spray mixture. Storage of the spray mixture beyond 72 hours is not recommended.

Do not use tank additives that alter the pH of the spray solution below pH 5 or above pH 8. Buffer the spray solution to alter the pH range as appropriate.

#### Mixing with Liquid Fertilizers:

Use suitable sources and rates of fertilizer based upon local recommendations. Refer to the mixing directions on the labels of the liquid fertilizers (e.g. UAN or urea solutions). Always perform a jar compatibility test before large scale mixing.

## **GROUND EQUIPMENT:**

Power sprayers fitted with a boom or spray wand/gun may be used for broadcast applications and spot treatments. For best spray distribution and coverage, select a spray volume and delivery system that will ensure accurate and uniform coverage. Boom sprayers equipped with appropriate flat fan nozzles, tips, and screens are suitable for broadcast applications. Do not use flood nozzles, Raindrop<sup>®</sup>, or nozzle tips larger than 8008. Spray droplets larger than 400 microns may reduce coverage and subsequent loss in weed control.

Spray volumes of 3 - 175 gallons per acre with spray pressures adjusted to 20 - 40 psi are appropriate. Use higher spray volumes for dense weed populations.

Hand operated sprayers including backpack sprayers, compression sprayers, and knapsack sprayers appropriate for small turfgrass areas when power equipment is unavailable, uneconomical, or impractical.

Hand-held techniques: Wands fitted with flat fan nozzle tips may be used with the appropriate technique. Flat fan nozzles should not be waved in a back-and-forth motion, or in a side-to-side motion, or in a swinging arm motion. Instead the nozzle should be held stationary at the proper height. Side to side motions result in uneven coverage.

This product may cause injury to susceptible/nontarget plants at the use site by contacting the foliage, stems, or roots. To prevent injury to susceptible crops and other desirable broadleaf plants including but not limited to cotton, legumes, tobacco, tomatoes, garden/vegetable crops, and ornamentals (flowers, trees, and shrubs) avoid contact with the spray solution, spray droplets, and spray mist (fine droplets). Applications are recommended only when there is no potential hazard from spray drift during dormant and active growth periods.

After using this product, clean sprayer with soap or detergent and water, or an approved spray tank cleaner and rinse thoroughly before applying other pesticides.

A variety of factors including weather conditions (e.g., wind direction, wind speed, temperature, relative humidity) and method of application (e.g., ground, aerial, airblast, chemigation) can influence pesticide drift. The applicator must evaluate all factors and make appropriate adjustments when applying this product.

## **Droplet Size**

When applying sprays that contain 2,4-D as the sole active ingredient, or when applying sprays that contain 2,4-D mixed with active ingredients that require a Coarse or coarser spray, apply only as a Coarse or coarser spray (ASAE standard 572) or a volume mean diameter of 385 microns or greater for spinning atomizer nozzles.

When applying sprays that contain 2,4-D mixed with other active ingredients that require a Medium or more fine spray, apply only as a Medium or coarser spray (ASAE standard 572) or a volume mean diameter of 300 microns or greater for spinning atomizer nozzles.

#### Wind Speed

Do not apply at wind speeds greater than 15 mph. Only apply this product if the wind direction favors ontarget deposition and there are not sensitive areas (including, but not limited to, residential areas, bodies of water, known habitat for nontarget species, nontarget crops) within 250 feet downwind. If applying a Medium spray, leave one swath unsprayed at the downwind edge of the treated field.

#### **Temperature Inversions**

If applying at wind speeds less than 3 mph, the applicator must determine if: a)conditions of temperature inversion exist, or b) stable atmospheric conditions exist at or below nozzle height. Do not make applications into areas of temperature inversions or stable atmospheric conditions.

#### **Susceptible Plants**

Do not apply under circumstances where spray drift may occur to food, forage, or other plantings that might be damaged or crops thereof rendered unfit for sale, use or consumption. Susceptible crops include, but are not limited to, cotton, okra, flowers, grapes (in growing stage), fruit trees (foliage), soybeans (vegetative stage), ornamentals, sunflowers, tomatoes, beans, and other vegetables, or tobacco. Small amounts of spray drift that might not be visible may injure susceptible broadleaf plants.

2,4-D esters may volatilize during conditions of low humidity and high temperatures. Do not apply during conditions of low humidity and high temperatures.

#### Equipment

All ground application equipment must be properly maintained and calibrated using appropriate carriers or surrogates.

Additional requirements for ground boom application: Do not apply with a nozzle height greater than 4 feet above the crop canopy.

#### WHERE TO USE:

Speed Zone Broadleaf Herbicide provides selective broadleaf control in warm season and cool season turfgrass in five (5) use sites.

- Institutional sites are defined as turf areas around properties or facilities providing a service to public or private organizations including, but not limited to hospitals, nursing homes, schools, museums, libraries, sport facilities, golf courses (fairways, aprons, and roughs), and office buildings.
- Ornamental sites include turfgrass established around residences, parks, streets, retail outlets, cemeteries, industrial and institutional buildings, recreation areas, fairgrounds, and areas adjacent to athletic fields.
- Residential/domestic sites are defined as areas associated with the household or home life including, but not limited to apartment complexes, condominiums, and patient care areas of nursing homes, mental institutions, hospitals, or convalescent homes.
- Agricultural site: Commercial sod production
- Noncropland Sites: Highway rights-of-way (principal, interstate, county, private, and unpaved roads): Roadsides, roadside ditches, road shoulders, road embankments, dividers, and medians. Municipal, state, and federal lands: Airports and military installations.

#### **Prohibitions of Sites:**

- Do not apply to any body of water such as lakes, streams, rivers, ponds, reservoirs, or estuaries (salt water bays). Do not apply to any shorelines (noncropland sites adjacent to the edges of a body of water) for lakes, streams, rivers, ponds, reservoirs, or estuaries (salt water bays).
- Do not apply to wetlands (swamps, bogs, potholes, or marshes).
- Do not apply to agricultural irrigation water or on agricultural irrigation ditchbanks and canals.
- Do not apply to agricultural drainage water or on agricultural ditchbanks.
- Do not apply this product to bentgrass greens, St. Augustinegrass, carpetgrass, dichondra, legumes, and lawns where desirable clovers are present.

#### **APPLICATION SCHEDULES:**

Early postemergent applications of Speed Zone Broadleaf Herbicide are recommended for annual, biennial, and perennial weeds. Apply Speed Zone Broadleaf Herbicide to broadleaf weeds that are young and actively growing for the best results. Speed Zone Broadleaf Herbicide combines a contact herbicide with systemic herbicides and provides little or no residual activity at recommended use rates.

Speed Zone Broadleaf Herbicide may be applied as a single broadcast application or as a split/sequential broadcast applications in the spring, summer, or fall. Spring and fall treatments under adequate soil moisture conditions are preferred to the summer treatments. Generally, summer broadcast applications to older, drought stressed weeds are less effective.

Sequential broadcast applications or follow-up applications as spot treatments at a 2 - 6 week interval are recommended for more mature weeds, for dense infestations, and for adverse environmental conditions. Spot treatments during the summer may be appropriate for sparse infestations, or as a follow-up treatment anytime broadleaf weeds are susceptible. Apply on a spray-to-wet basis for the best results.

Extremes in environmental conditions e.g. temperature and moisture, soil conditions, and cultural practices may affect the activity of Speed Zone Broadleaf Herbicide. Under warm moist conditions, herbicide symptoms may be accelerated. While under very dry conditions, the expression of herbicide symptoms is delayed, and weeds hardened off by drought are less susceptible to Speed Zone Broadleaf Herbicide.

## For newly seeded areas:

 The application of Speed Zone Broadleaf Herbicide to grass seedlings is recommended after the second mowing.

#### Reseeding interval:

• Treated areas may be reseeded 1 week after application.

# For newly sodded, sprigged, or plugged areas:

• The application of Speed Zone Broadleaf Herbicide to newly sodded, sprigged, or plugged grasses should be delayed until 3 to 4 weeks after the sodding, sprigging, or plugging operations.

#### For dormant turf:

 Applications to fully dormant bermudagrass, fully dormant zoysiagrass, and fully dormant buffalograss are suggested.

## Prohibitions for application schedules:

• Do not broadcast apply when air temperatures exceed 90°F; some injury may be expected with spot treatments when air temperatures exceed 90°F.

#### **USE RATES AND SPRAY VOLUMES FOR TURFGRASS:**

Generally, the lower application rates within the specified range will provide satisfactory control of sensitive weed species. The higher application rates within the specified range will be required for dense infestations of perennial weeds, for adverse/extreme environmental conditions, or for weeds beyond the appropriate growth stages.

Use rates and spray volumes of Speed Zone Broadleaf Herbicide as a broadcast treatment for use on turfgrass are presented in Table 1.
