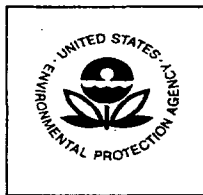

On the basis of information furnished by the registrant, the above named pesticide is hereby registered/reregistered under the Federal Insecticide, Fungicide and Rodenticide Act. Registration is in no way to be construed as an endorsement or recommendation of this product by the Agency. In order to protect health and the environment, the Administrator, on his motion, may at any time suspend or cancel the registration of a pesticide in accordance with the Act. The acceptance of any name in connection with the registration of a product under this Act is not to be construed as giving the registrant a right to exclusive use of the name or to its use if it has been covered by others.

This product is reregistered in accordance with FIFRA section 4(g)(2)(C) provided you:

- 1. Submit and/or cite all data required for registration/reregistration review of your product when the Agency requires all registrants of similar products to submit data.
2. Contain this product in child-resistant packaging.
3. Make the following revisions to the final printed labeling:
a. Per the acute toxicity review, the Hazards to Humans and Domestic Animals must read: "DANGER: Corrosive. Causes irreversible eye damage. Harmful if swallowed. Do not get in eyes, on skin or clothing."
b. Per the RED combined label table, the PPE listed as "protective eyewear" must be revised to "goggles or face shield". In addition, "chemical-resistant gloves when applying with any..." must be revised to "chemical-resistant gloves (except for applicators using groundboom equipment)."

- c. Per the RED combined label table, the 'User Safety Requirements' section must have the following statement added:

"Discard clothing and other absorbent material that have been drenched or heavily contaminated with the product's concentrate. No not reuse them."

- d. Per the acute toxicity review, the First Aid section headings must be in the following order:
"If in Eyes..."
"If Swallowed..."
"If on Skin or Clothing..." NOTE: This is not required, but may remain on the label.
"If Inhaled..." NOTE: This is not required, but may remain on the label.

In addition, a phone number for emergency medical treatment information should be added to the First Aid section.

- e. Per the acute toxicity review, a Note to Physician must be added to the label and must read:
"Note to Physician: Probable mucosal damage may contraindicate the use of gastric lavage."

In addition, the Agency recommends that additional text be added to the Note to Physician that addresses eye irritation concerns as this product is a category level I for primary eye. The following statements are some suggested types of information that could be included:

- technical information on symptomatology;
- use of supportive treatments to maintain life functions;
- medicine that will counteract the specific physiological effects of the pesticide

- f. Per the RED combination label table, the first two sentences of the Environmental Hazards section must read as follows:

"This pesticide is toxic to fish and aquatic invertebrates. Do not apply directly to water, to areas where surface water is present, or to intertidal areas below the mean high water mark."

- g. Per the RED combination label table, the 'Application Rates for Ornamental Turfgrasses' may be revised with the underlined text and must be revised with text in **bold**:

"For selective broadleaf control in ornamental turf, apply a maximum of 4.5 pints of product per acre per application (1.5 lbs. ae 2,4-D/acre)..."

"The maximum application rate is 4.5 pints of product per acre per application (1.5 lbs 2,4-D acid equivalent per acre per application). The maximum number of broadcast applications is limited to 2 per year **with a minimum of 30 days between applications**. The maximum seasonal rate is 9.0 pints of product per acre (3.0 lbs 2,4-D acid equivalent per acre), excluding spot treatments. **For spot treatments: Do not exceed 1.2 lbs ae MCPP-p/A per application (1/3 pint of product per 1000 ft. sq.) Do not make more than 2 spot treatments per year with a minimum retreatment interval of 30 days. A spot treatment is defined as an area not greater than 1000 ft. sq.**"

- h. Per the RED combination label table, the 'Spray Drift Management' section must have the following revisions:
 - **1st paragraph**
Remove "(e.g., ground, aerial, airblast, chemigation)" and place the text "ground" in front of "application."
 - **Droplet Size**
Revise the whole paragraph to:
"Use only Medium or courser spray nozzles according to ASAE (S572) definition of standard nozzles or a volume mean diameter of 300 microns or greater for spinning atomizer nozzles."
 - **Wind Speed:**
Change the wind speed from "greater than 15 mph." to "greater than 10 mph."
In addition, remove the last sentence "If applying a Medium spray..."
 - **Equipment:**
Delete "aerial and"

i. Revise the 'Container Disposal' section to comply with the residue removal language in PR Notice 2007-4. See Chapter 13 of the Label Review Manual for guidance at <http://www.epa.gov/oppfead1/labeling/lrm/chap-13.htm>.

j. Add the statement "To the extent consistent with applicable law" before "THE MANUFACTURER NEITHER MAKES NOR INTENDS..." in the 'Limited Warranty and Disclaimer' section.

k. The 'Net Contents/Net Weight' must always be presented on the front panel of the labeling. See FIFRA 2(q)(2)(C)(iii); 40 CFR 156.10(a)(1)(iii). (i.e. Appendix "Statements which may appear on different label components...")

l. Add the following statement to the label:

"Use of this product in certain portions of California, Oregon and Washington is subject to the January 22, 2004 Order for injunctive relief in Washington Toxics Coalition, et al.v. EPA, C01-0132C, (W.D. WA). For further information, please refer to <http://www.epa.gov.espp>."

4. A stamped copy of your labeling is enclosed for your records. You must submit one (1) copy of the final printed label before you release the product for shipment. Products shipped after 12 months from the date of this Notice or the next printing of the label whichever occurs first, must bear the new revised label. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

PRECAUTIONARY STATEMENTS

Hazards to Humans and Domestic Animals

DANGER: Corrosive. Causes irreversible eye damage. Do not get in eyes, on skin or clothing. Wear protective eyewear such as goggles, face shield, or safety glasses. Harmful if swallowed, if absorbed through skin or if inhaled. Avoid breathing spray mist.

Some materials that are chemical-resistant to this product are natural rubber, natural rubber blends and laminates. If you want more options, follow the instructions for category A on an EPA chemical-resistance category selection chart.

All mixers, loaders, applicators, flaggers, and other handlers must wear:

User Safety Requirements

Engineering Control Statements

For container sizes over 1 gallon and less than 5 gallons: Persons engaged in open pouring of this product must also wear coveralls or a chemical resistant apron.

For container sizes of 5 gallons or more: Do not open pour product from this container. A mechanical system (probe and pump or spigot) must be used for transferring the contents of this container. If the contents of a non-refillable pesticide container are emptied, the probe must be rinsed before removal.

User Safety Recommendations

- Users should wash hands before eating, drinking, chewing gum, using tobacco, or using the toilet.
- Users should remove clothing/PPE immediately if pesticide gets inside. Then wash thoroughly and put on clean clothing. If pesticide gets on skin, wash immediately with soap and water.

Environmental Hazards

This pesticide may be toxic to fish and aquatic invertebrates. Do not apply directly to water, to areas where surface water is present, or to intertidal areas below the mean high water mark except as noted on appropriate labels. Drift and runoff may be hazardous to aquatic organisms in water adjacent to treated areas. Do not contaminate water when disposing of equipment wash waters or rinsate.

This chemical has properties and characteristics associated with chemicals detected in groundwater. The use of this chemical in areas where soils are permeable, particularly where the water table is shallow, may result in groundwater contamination. Application around a cistern or well may result in contamination of drinking water or groundwater.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

General Precautions and Restrictions:

- Do not enter or allow people (or pets) to enter the treated area until sprays have dried.
- Do not apply this product in a way that will contact workers or other persons, either directly or through drift. Only protected handlers may be in the area during application.

SITES:

EH-1395 Herbicide is intended to be applied by lawn care operators and landscape personnel for use in ornamental lawns and turf established in ornamental sites. Ornamental sites include turfgrass established around residences, parks, streets, retail outlets, cemeteries, industrial and institutional buildings. Cool season turfgrass species include Kentucky bluegrass, perennial ryegrass, and the fescues.

MIXING INSTRUCTIONS WITH WATER AS THE CARRIER

1. Prepare only the amount of spray mixture which can be used the day that it will be sprayed.
2. Fill the spray tank with 1/2 to 3/4 of the required amount of water and begin agitation. Sufficient agitation during mixing and application is essential.
3. Add EH-1395 Herbicide into the spray tank and maintain continuous agitation to avoid separation.
4. Fill the spray tank to 3/4 of the required amount of water. If tank mixtures are being prepared, add the companion product when the spray tank is approximately 3/4 full.
5. Finally, add the balance of the required water volume and maintain agitation prior to and during the application.

APPLICATION RATES FOR ORNAMENTAL TURFGRASS

For Kentucky bluegrass, Fescue spp., and Perennial Ryegrass:

For selective broadleaf control in ornamental turf, apply a maximum of 2.91 pints of product per acre per application with spray volumes ranging from 20 to 220 gallons per acre.

The maximum application rate is 2.91 pints of product per acre per application (0.97 lbs 2,4-D acid equivalent per acre per application). The maximum number of broadcast applications is limited to 2 per year. The maximum seasonal rate is 5.82 pints of product per acre (1.95 lbs 2,4-D acid equivalent per acre), excluding spot treatments.

USE PRECAUTIONS:

Do not apply this product through any type of irrigation system. Do not spray on carpetgrass, dichondra, nor on lawns or turf where desirable clovers are present.

Use only lawn-type sprayers. Do not spray roots of ornamentals and trees. Do not exceed specified dosages for any area. Be particularly careful within the dripline of trees and other ornamental species. Do not apply to newly seeded grasses until well established. Do not broadcast apply when air temperatures exceed 85°F; some injury may be expected with spot treatments when air temperatures exceed 85°F. Seed can be sown 3 to 4 weeks after application at recommended rates.

Spray Drift Management

A variety of factors including weather conditions (e.g., wind direction, wind speed, temperature, relative humidity) and method of application (e.g., ground, aerial, airblast, chemigation) can influence pesticide drift. The applicator must evaluate all factors and make appropriate adjustments when applying this product.

Droplet Size

When applying sprays that contain 2,4-D as the sole active ingredient, or when applying sprays that contain 2,4-D mixed with active ingredients that require a Coarse or coarser spray, apply only as a Coarse or coarser spray (ASAE standard 572) or a volume mean diameter of 385 microns or greater for spinning atomizer nozzles.

When applying sprays that contain 2,4-D mixed with other active ingredients that require a Medium or more fine spray, apply only as a Medium or coarser spray (ASAE standard 572) or a volume mean diameter of 300 microns or greater for spinning atomizer nozzles.

Wind Speed

Do not apply at wind speeds greater than 15 mph. Only apply this product if the wind direction favors on-target deposition and there are not sensitive areas (including, but not limited to, residential areas, bodies of water, known habitat for nontarget species, nontarget crops) within 250 feet downwind. If applying a Medium spray, leave one swath unsprayed at the downwind edge of the treated field.

Temperature Inversions

If applying at wind speeds less than 3 mph, the applicator must determine if: a) conditions of temperature inversion exist, or b) stable atmospheric conditions exist at or below nozzle height. Do not make applications into areas of temperature inversions or stable atmospheric conditions.

Susceptible Plants

Do not apply under circumstances where spray drift may occur to food, forage, or other plantings that might be damaged or crops thereof rendered unfit for sale, use or consumption. Susceptible crops include, but are not limited to, cotton, okra, flowers, grapes (in growing stage), fruit trees (foliage), soybeans (vegetative stage), ornamentals, sunflowers, tomatoes, beans, and other vegetables, or tobacco. Small amounts of spray drift that might not be visible may injure susceptible broadleaf plants.

Other State and Local Requirements

Applicators must follow all state and local pesticide drift requirements regarding application of 2,4-D herbicides. Where states have more stringent regulations, they must be observed.

Equipment

All aerial and ground application equipment must be properly maintained and calibrated using appropriate carriers or surrogates.

Additional requirements for ground boom application: Do not apply with a nozzle height greater than 4 feet above the crop canopy.
