## DIRECTIONS FOR USE

**IMPORTANT:** Read these entire Directions and Conditions of Sale, including the Warranty and Limitation of Damages provision, before using CO-RAL Duster.

**CONDITIONS OF SALE:** These Directions for Use reflect the opinion of experts based on tests of effectiveness, of toxicity to plants and laboratory animals and of residues on or in food and feed under normal conditions of use. However, because of the wide range of conditions under which this product may be used, even though label directions are followed, it is impossible to eliminate all risks associated with its use because of abnormal conditions beyond the control of the seller. Cotton Producers Association and the Seller offer, and the Buyer uses, this product subject to the understanding that the Seller offers, and the Buyer assumes all such risks.

### HORN FLY CONTROL:

Suspend CO-RAL Duster in areas frequented by cattle or in gateways or lanes through which the animals pass daily for water, feed or mineral. Dusters may also be suspended in loafing sheds or in front of protected mineral feeders. For lactating dairy cows, CO-RAL Duster may be suspended in the exit through which cows leave the milking barn. In all cases, the Duster bags should be adjusted so that the bottom of the bag will hang four to six inches below the topline of the cattle.

### FACE FLY AND HORN FLY CONTROL:

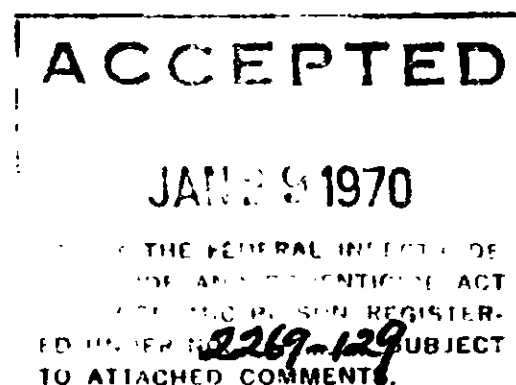
Suspend CO-RAL Duster in the same manner as described under "Horn Fly Control" except as follows: (1) The bottom of the bags should be about 24 inches from the ground to insure that the faces of the cattle will be dusted. (2) The Dusters must be located so the animals will be forced to use them daily.

### INSTALLATION OF CO-RAL DUSTER:

Suspend the Duster bags by inserting rope, chain, or wire through the grommets at the top of the bag and attaching to an overhead structure or by hooking the grommets into hooks fixed to a stationary overhead 2x4 at the heights recommended for horn fly or face fly control. In areas of frequent or heavy rainfall, CO-RAL Duster should be protected from the weather.

Install as many 10-pound CO-RAL Dusters as necessary in lanes or other openings to assure proper dusting of the animals. When dust bags are provided on a free-choice basis, allow one 10-pound CO-RAL Duster per 10 to 20 animals. After the bags are in place, pull the rip cord to allow the insecticide to fall into the bottom of the bag.

## RESTRICTIONS:

Do not hang duster over feed, mineral, or water troughs.

To Physician—Atropine sulfate is antidotal. 2-PAM is also antidotal and may be administered in conjunction with atropine.
