CORN—Fall Armyworms, use $2\frac{1}{2}$ pts. per acre. Corn Earworms, use $1\frac{1}{2}$ to 2 pts. per acre. Do not feed treated forage to dairy animals or animals being finished for slaughter.

CABBAGE—Cabbage Loopers—Use 1½ to 2 pts. per acre. For control of Armyworms, use 2 pts. per acre. Do not apply to Broccoli. Brussels Sprouts, and Cauliflower after edible parts start to form.

POTATOES—Loopers—Use 1 to 1½ pts. per acre. For control of Armyworms and grasshoppers, use 1½ to 2 pts. per acre. Foliage treatment only. No time limitation.

TOMATOES—Cabbage Loopers, Climbing Cutworms, Tomato Hornworms, Tomato Fruitworms, Tomato Pinworms, Flea Beetles—Use 1½ to 4 pts. per acre. For control of Armyworms, use 2 pts. per acre. Do not apply within 3 days of harvest.

COTTON—Armyworms, Boll Weevils, Bollworms, Cotton Leafworms, Climbing Cutworms, Flea Beetles, Fleahoppers, Grasshoppers, Plant Bugs. Thrips—Use 2 to 4 pts. per acre.
