## **DIRECTIONS FOR USE**

Toxaphene Emulsifiable Concentrate should be diluted or mixed with water for application as a spray. To mix, pour correct amount of concentrate into known volume of water in spray tank and stir or agitate thoroughly. If allowed to stand after mixing, re-agitate thoroughly before use. Some agitation is required during application.

COTTON-To control boll weevil, bollworm (does not include pink bollworm), fleahopper, thrips, lygus bug and other mirids, cutworms, and leafworm. Use  $\frac{1}{3}$  to  $\frac{2}{3}$  gal. (2 to 4 lbs. toxaphene) in the amount of water required for uniformly thorough spraying of 1 acre of cotton. Apply at the lower rate during the early season and at the higher rate during and after the blooming period.

For cutworms, apply when worms appear during early season, usually at 2 to 4-leaf stage; repeat when necessary. For thirps and fleahoppers, begin at 2 to 4-leaf stage and repeat at 7-day intervals if needed. For lygus bug and other mirids, apply when damage first appears; repeat as needed. For bollworm, apply when eggs or 3 to 4 small larvae per 100 terminal buds are found; repeat application at weekly intervals until infestation is controlled. Late season control of bollworm may require applications to be repeated at 4 to 5-day intervals as needed.

For boll weevil, during early season, apply at 2 to 4-leaf stage or at first squaring, if weeils are present, and make 3 to 4 applications at weekly intervals as necessary; during mid and late-season, apply when 10 percent of the squares or bolls are punctured and repeat at 4 to


