This product will pass 90% through a 325 mesh screen.

5% Malathion Dust is a combination insecticidal and miticidal dust for use against certain insect and mite pests.

**DIRECTIONS**

**TOMATOES:** Dust at the rate of 3½-4 lbs. per 4,356 square feet (one or more applications as needed) to control aphids and spider mite.

**BEANS:** Dust at the rate of 2½-3 lbs. per 4,356 square feet at 5 to 7 day intervals to control Mexican Bean Beetles, Leaf Hoppers and Spider Mite. For best control of Mexican Bean Beetles, direct the dust to the underside of the leaves.

**CABBAGE, COLLARDS AND TURNIPS:** To control Aphids, imported Cabbage Worms, and Cabbage Looper, dust at 2½-3 lbs. per 4,356 square feet at 5 to 7 day intervals.

**CUCUMBER, SQUASH, AND MELONS:** Dust at the rate of 2½-3 lbs. per 4,356 square feet at 5 to 7 day intervals to control Aphids, Spider Mites. Do not Apply to plants unless dry or injury may result.

**ORNAMENTAL FLOWERS AND SHRUBS:** Against Aphids and Spider Mites apply as needed for good coverage or at 2½-3 lbs. per 4,356 square feet in nursing planting.

**ALFALFA:** Dust at the rate of 3 lbs. per 4,356 square feet (repeat as necessary) to control Aphids, Spider Mites, Alfalfa Weevil larvae, Potato Leaf Hoppers and Spittle Bugs. When alfalfa is in bloom apply only in evening or early morning when bees are not working in the field.

**(CAUTION)**

Do not apply to Alfalfa later than 1 day before harvest.  
Do not apply to Tomatoes, Beans, Squash, Cucumbers, and Melons later than 1 day before harvest.  
Do not apply to Cabbage and Collards within 7 days of harvest.  
Do not apply to Turnips within 3 days of harvest.
