EXCELCIDE Outside Residual should be residually applied once every week to 10 days or up to two weeks or even more often if necessary to surfaces outside the plant where flies roost. Under certain conditions, this product may continue to kill flies for as long as 4 to 5 weeks.

Such surfaces should be thoroughly wetted down until they are glistening wet but not running.

The application should be made with a tank-type nonmisting sprayer equipped with a fan-pattern nozzle.
