

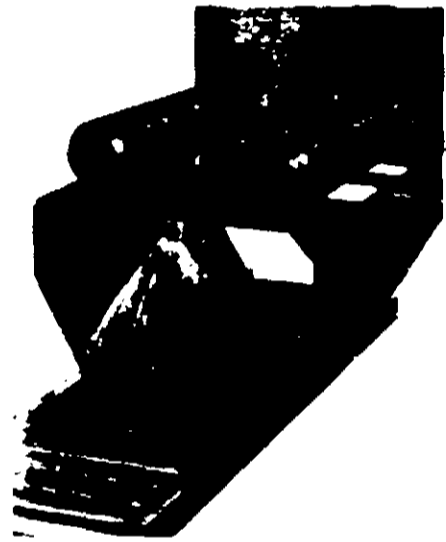

This product is a concentrate, to be diluted with water as per directions, and used in either model of the EXCELCIDE Bottle Case Sprayers, to coat the interior surface of shells, cases, and cartons. Such a coating will repel roaches that attempt to enter the case.

CONTAINER DISPOSAL

DRUMS: Do not reuse empty drum. Return drum to reconditioner or destroy by perforating or crushing and burying in a safe place away from water supplies.

PAILS: Do not reuse empty container. Destroy it by perforating or crushing. Bury or discard in a safe place away from water supplies.

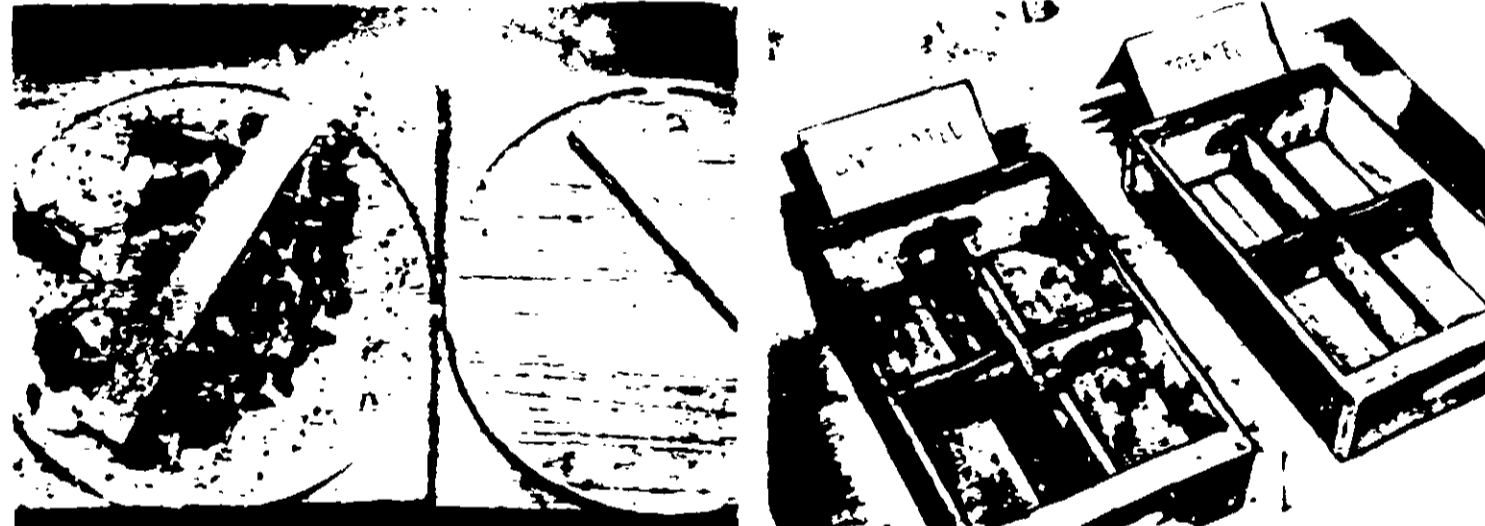

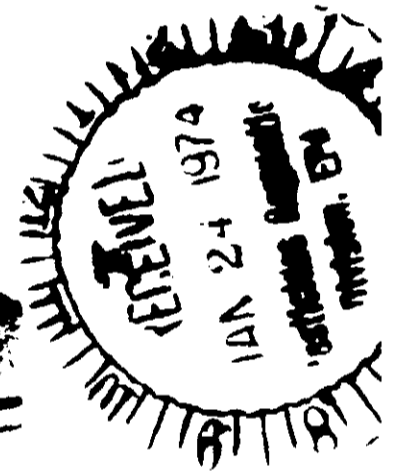

DIRECTIONS

Dilute this product at the rate of 1 part concentrate to 4 parts water (add 26 oz. of concentrate to 102 oz. of water to make 1 gallon.) Stir solution after dilution. Cases, shells and cartons should be lightly wetted down before filling. Repeat treatment when necessary. The EXCELCIDE Bottle Case Sprayer and the EXCELCIDE Deluxe Bottle Case Sprayer are available for automatic application. Both are air-operated and usually attached right to the conveyor or filler line. The cases are treated as they pass under the orifices, at the approximate dosage of 2 cc (1.15 oz.)
