

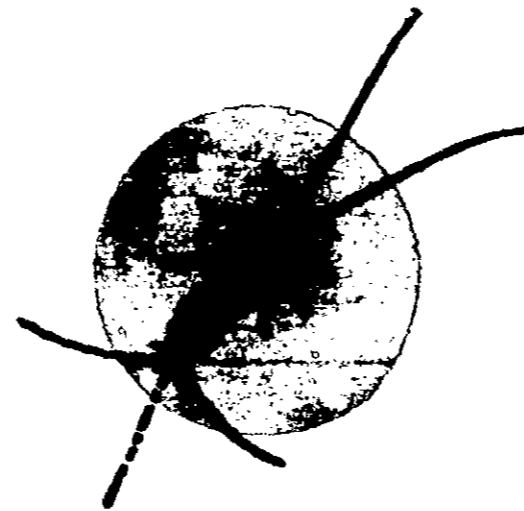
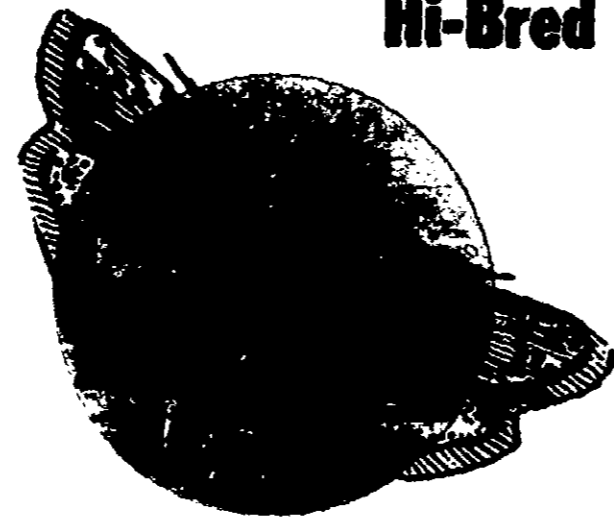

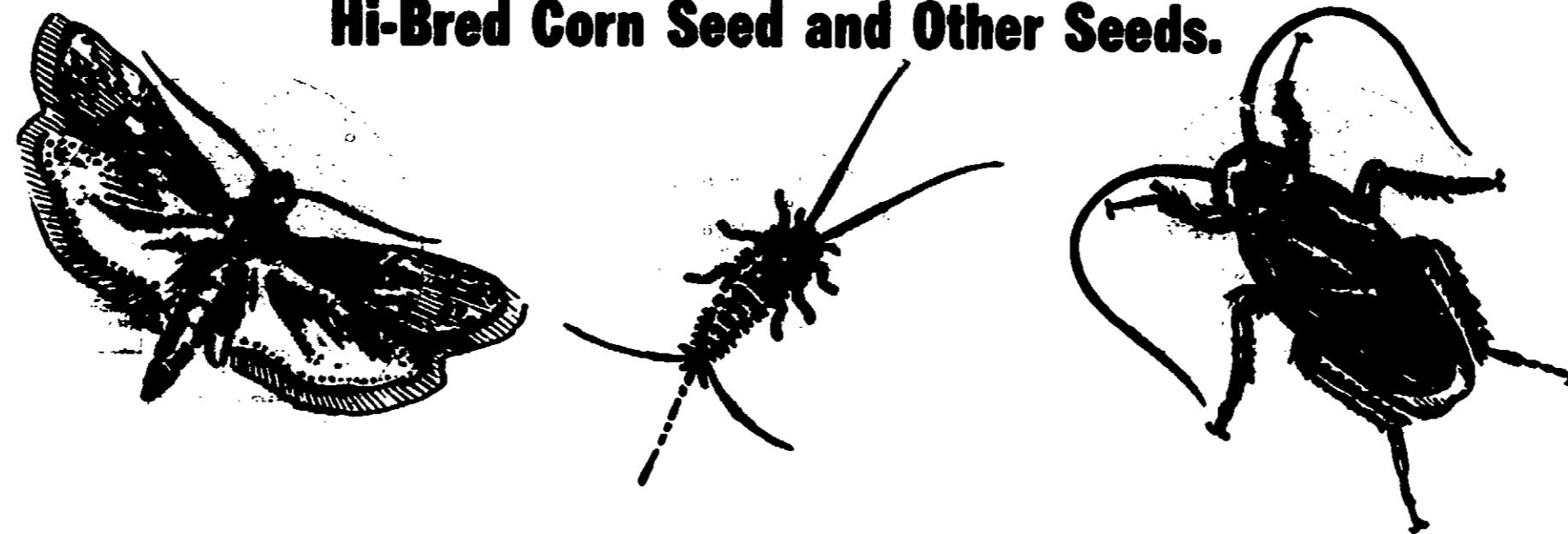

## DIRECTIONS

This material is preferably used in tank type sprayer with a fan-pattern nozzle. The surfaces to be treated should be wetted down to a point where they are glistening wet and yet the material does not run, so as to form a lethal film or deposit.

It should be applied anywhere from once a week to once every 3 weeks, depending on conditions and prevalency of insects.

It is designed particularly for crawling insects such as American Cockroach, German Cockroach, and Oriental Cockroach, silverfish, firebrats, and such stored product pests as Confused Flour Beetles, Saw-Toothed Grain Beetles, Cadelles in their exposed stages.

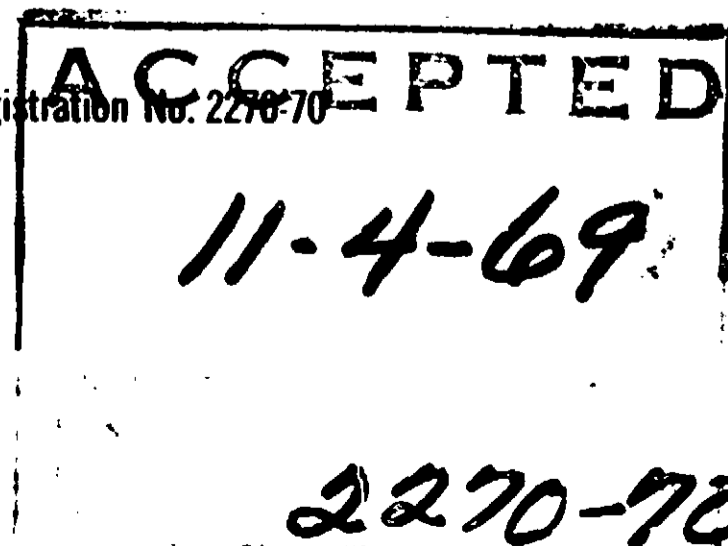
For control of flying insects (Houseflies, Gnats, Moths, Drosophila) residual application of EXCELCIDE Seed Warehouse Spra should be applied in a residual wetting-down treatment to surfaces on which the insects alight or crawl.

It is strongly urged that any static accumulations upon which these insects might feed or breed not be allowed to remain dormant in hidden corners or ledges, and instead be thoroughly and periodically vacuumed before applying the spray. Housekeeping is the first principle of stored product pest control and EXCELCIDE Seed Warehouse Spra can achieve best results if good basic sanitation practices are used in conjunction.
