## DIRECTIONS

EXCELCIDE 2% Malathion Residual Mater Based should be applied to all insect the quented surfaces inside the plant at regular 2 - 4 week intervals.

This formula is designed to control exposed stages of grain weevils and saw-toothed grain beetles, crawling inserts cockroaches and silverfish and tiying insects: flies, gnats, & mosquitoes which will alight and rest on the treated surface.

For treatment inside boxcars, the material should be used either with a tank-type sprayer or with a power sprayer so as to coat the entire wall surface of the boxcar in an effort to control insects that might emerge from behind the walls and contaminate the goods during shipment.
