



### DIRECTIONS

This residual spray, when diluted at the rate of one part concentrate to 7 parts oil combines the insect agitating characteristics of Pyrethrin-Piperonyl Butoxide synergisms and the residual qualities of Cythion Insecticide, The Premium Grade Malathion.

EXCELCIDE Malathion-Pyrethrin (oil soluble), when diluted at the suggested rates, is a surface spray designed to combat exposed insects: cockroaches, ants, spiders, crickets, and carpet beetles. Use this product as wet course spray for residual protection in food processing plants, flour mills, grain elevators and empty grain bins. Do not use in edible products areas of food processing plants, restaurants or other areas where food is commercially prepared or processed. Do not use in serving areas while food is exposed.
