

#### **USE RESTRICTIONS**

For use as a repellent against dogs and cats. Do not a ply on plants intended for food or feed. Do not apply t dichondra or unusual ground covers.

#### SPECIAL INSTRUCTIONS FOR LAWNS

Apply directly on established lawns. For new lawn spread over soil after it has been seeded. Roll and wi immediately. Apply a 2" wide band around plant flowers, foliage and painted surfaces. Spread 6" awa from plants or trees. Wet well so that the repellent wi adhere to the soil.

AS A DOG REPELLENT: To prevent defecation or urintion by dogs on lawns, flower and vegetable gardens of around hedges, trees, shrubs or vines, remove old featuraterial and sprinkle evenly on the affected area usin 1 lb, per 40 sq. ft. Reapply at least once per week or unt dogs no longer defecate the area. Resume treatment problem reoccurs.

AS A CAT REPELLENT: To prevent cats digging flower gardens. lawns. beside vegetable gardens ar under bushes, fill existing holes and apply evenly on the affected area at the rate of 1 lb. per 40 sq. ft. Reapply a least once a week until the digging stops. Resume treat ment if problem reoccurs.
