

Sulphur may burn foliage and fruit during periods of high temperature. Do not apply sulphur to sensitive crops when shade temperatures exceed or are likely to exceed 90° F. Do not use sulphur within three weeks of an oil spray. Do not use sulphur on cucurbits (cucumber, cantaloupe, meion, squash), as it may result in injury to the plants.

DIRECTIONS FOR USE

The Federal Food and Drug Administration has set official tolerances for certain pesticide residues. In order that residues on food and forage crops will not exceed established tolerances, use only at recommended rates, and do not apply closer to harvest than specified. Consult local agricultural authorities for additional information, as the timing, number and rate of applications needed will vary with local conditions.

RECOMMENDATIONS

Use the higher dosage during periods of frequent and heavy rainfall. Spray often enough to feep new growth covered. This may require weekly or bi-weekly applications during periods of rapid growth and frequent rainfall.

BEANS - For control of Powdery Mildew, use 6 to 8 lb. per 100 gallons of water.

CITRUS - For control of Rust Mite, use 8 to 10 lb. per 100 gallons of water.

ROSES - For control of Black Spot and Powdery Mildew, use 6 to 8 lb. per 100 gallons of water.
