FASCO LIQUID FLAME is a non-selective non-systemic contact herbicide or weed killer that is readily diluted with water to the desired strength for use as a spray. This product is designed for quickly top killing many annual and perennial type weeds.

For use on Walkways and under Benches in Shade or Graen-houses; and Conned Plant areas (Among cans and walkways). Also useful along Fence Rows, Paths, Driveways, Parking Lets around Buildings and Vacant Lots and for edging lawns.

### DIRECTIONS

Use as a course wetting spray with only enough pressure (about 25 to 30 lbs.) to penetrate through the foliage to thoroughly wet the stems. Works best when weeds are dry. Keep the spray off above-ground parts and exposed roots of trees, shrubs or other valuable plants.

Power sprayers with sufficient host, and small air pressure (pump-up) sprayers with 5 ft. of hose may be used. In either case attach to the hose a lover type shut-off valve with a two ft. long extension pipe (wand) and nozzle so that the nozzle can be operated very close to the ground from a standing position. A 65° fan type nozzle with even spray patiern is preferred. The TeeJet\* Flat Spray Nozzle with 6503 tip or 65015 tip is satisfactory.

For faster, more economical weeding in row-planted nursery stock and similar locations, use a 42 to 48 inch wand of 1/4 inc. aluminum pipe attached to the iever valve. Use 1/8 inch galvanized iron fittings at the other end of the wand to make a "T'-shape boom with a total of 4 to 8 nozzles spaced 3 inches apart. Set alternate nozzles to spray slightly forward or behind for "front and back" coverage. Use 65015 nozzle tips for the two end positions and 80015 tips for the interior positions. Hold the nozzles 4 to 6 inches from the ground and vary the walking speed, faster where weeds are small and scattered and slower for larger dense weed growth.

WATER DILUTION RATES (See Table) --- Dilute in water at the strength for the toughest weed types to be sprayed. Or use a dilution that kills most types, and a few days later make a second "spot" application on the tougher weeds using a stronger dilution.
