**FASCO C-Z-M 755** is a wettable powder concentrate containing neutral copper, neutral zinc, and neutral manganese, for use primarily on citrus, as directed below.

**DIRECTIONS**

Use contrary to these directions may result in injury to the foliage or fruit, in unsatisfactory control or in other unintended consequences.

**CITRUS:** Use 18 lbs. per 500 Gals. of spray (3.6 lbs. per 100 Gals.) For concentrate sprays increase proportionately. Sift into tank when one half to two thirds filled with water. Be sure to have agitator running while filling to insure adequate mixing.

**DORMANT** — Against Scab on Citrus, and against nutritional deficiencies of copper, zinc and manganese, apply just before growth appears, usually late January or early February. Where infection is severe increase concentration of spray by fifty percent.

**POST BLOOM SPRAY** — Against Scab, Melanose, and to supply nutritional copper, zinc and manganese apply one to two weeks after petal fall. Spray thoroughly to cover all twig and leaf area, being particularly careful to cover the top-most parts of trees.

**NOTE** — This product mixes well in spray with other commonly used materials such as Zineb, Chlorobenzilate, Kelthane, Borax, Lead Arsenate and Oils.

**CAUTION: KEEP OUT OF THE REACH OF CHILDREN.**

Don't keep poisons where food is handled or stored. Avoid contamination of feed or foodstuffs. Harmful if swallowed.

**ANTIDOTE**

If taken internally induce vomiting by giving mustard and water. J tickling the throat. Give large dose of magnesia or lime water. Follow with strong dose of Epsom Salts. Call a physician or take patient to hospital.
