FASCO POULTRY DUST C-R is an insecticidal dust formulation designed for use against Northern Fowl Mite, Lice, Poultry Red Mite, and Flies which infest Poultry. Direct application of the dust may be made to the birds by means of rotary or hand dusters, puff dusters, or by sprinkling from a can as directed below.

DIRECTIONS

Use contrary to these directions may cause injury to poultry, personal injury, excessive residues, unsatisfactory control or other unintended consequences.

DIRECT APPLICATION TO POULTRY (Chickens, Turkeys, Ducks, Geese) — For the control of Northern Fowl Mite and Lice, dust birds thoroughly, especially under wings and around vent. Supplemental control can be obtained by also treating litter and housing. Normally one pound of dust will treat 30-50 birds. Repeat as necessary but not more often than weekly.

LITTER AND HOUSING TREATMENT — For control of Northern Fowl Mite, Poultry Red Mite, Lice, and Flies, apply one pound of dust per 70 square feet of surface area to walls, ceiling, floor, roosts, nests, and adjacent areas, as well as per 20 square feet of litter area. Force dust into all cracks and crevices. Repeat as necessary.
