FASCO MOLE CRICKET BAIT is an insecticidal bait containing Chlordane and Toxaphene for use against Mole Crickets and Cutworms.

DIRECTIONS

Use contrary to these directions may cause serious plant, crop or personal injury, excessive residues, unsatisfactory control or other unintended consequences.

For best results apply in late afternoon.

MOLE CRICKETS, CUTWORMS: For use against Mole Crickets and Cutworms around Beans, Broccoli, Cabbage, Cauliflower, Collards, Eggplant, Peppers, Tomatoes, Flowering plants.

Apply broadcast to seed bed before planting and repeat as needed. Use 30 to 40 pounds of bait per acre.

After plants come up apply broadcast along rows and on the ground around the plants. To avoid injury and excessive residues do not apply directly to foliage or against base of plants. Do not apply after edible parts start to form.

Do not pile this bait on the soil above planted seed as injury may occur.

NOTE - The U. S. Food and Drug Administration has set tolerances for pesticide residues. Crops having residues in excess of their permitted tolerances should NOT be marketed and to do so may violate State law and will violate Federal law when sold in interstate commerce. Such crops should

not be marketed without removal of such excess residues.

LAWNS, GOLF COURSES: Against Mole Crickets, Armyworms, and Cutworms use 35 to 50 lbs. per acre broadcast. During dry weather water the soil thoroughly BEFORE application to bring the insects to the surface.

CAUTION

Harmful if swallowed. Avoid breathing dust. Avoid contact with eyes, skin, and clothing. Wash thoroughly after using. Avoid storage near feed and foodstuffs.

DANGER TO FISH AND WILDLIFE

This product is poisonous to fish and wildlife. Keep out of lakes, streams and ponds. Do not apply when weather conditions favor drift of this product from areas treated. Rinse equipment and containers and dispose of wastes by burying in non-crop lands away from water supplies. Containers should be disposed of by punching holes in them and burying with wastes, or by burning (keep out of smoke and fumes).
