FASCO CHLOROBOR-X® is a pelletized non-selective weed killer designed to be applied dry to the surface of the ground for control of weeds and grasses. The product is formulated for use on industrial and other non-crop breas such as Petroleum tank yards, Sawmills, Warehouses, Lumber yards, Power plants, Fences, Pipelines, around loading platforms, and Railroad sidings.

DIRECTIONS

NOTE—FASCO CHLOROBOR-X® must be spread uniformly at rates given for effective weed control. Apply with a Seeder or Granular Herbicide Applicator. Killing action is primarily through the roots of plants, so moisture is required after application to carry the chemical to the root zone. With too little moisture, results may be slow to appear. Avoid application in hot, dry weather.

FOR ANNUALS OR SHALLOW ROOTED PLANTS — Apply 1 pound per 100 Square Feet. Make application in the Spring or when weeds are small.

FOR PERENNIAL AND DEEP ROOTED PLANTS—Apply 1 to 1½ pounds per 100 Square Feet. Where Johnson, Bermuda, and Vasey grasses are a serious problem, apply 2 pounds per 100 Square Feet for first application. Make application whenever weeds and grasses are not over a few inches high. Rank vegetation should be cleared before treatment. This reduces fire hazard of dead weeds and aids in getting more even coverage of the area.

SPECIAL NOTE: Do NOT apply this product on croplands, pastures, or other agricultural areas. Do NOT apply this product where it may leach or wash to cropland or to any body of water.
