GRANSIL SUPER 85 PELLETS is a granular non-selective weedkiller designed to be applied dry to the surface of the ground for control of weeds. The kill of weeds may be slow as the chemical is absorbed through roots of weeds and must be carried to root zone by moisture. The degree of control and duration of effect will vary with the amount of chemical applied, soil type, rainfall, and other conditions.

DIRECTIONS

Apply GRANSIL SUPER 85 PELLETS just before or during the period of active growth of weeds.

GENERAL WEED CONTROL - To control most weeds for an extended period of time on non-cropland areas such as RAILROADS, HIGHWAY AND PIPELINE RIGHT-OF-WAYS, PETROLEUM TANK FARMS, LUMBERYARDS, STORAGE AREAS, and INDUSTRIAL PLANT SITES.

Apply 7 to 12 pounds per acre to control PERENNIAL WEEDS and GRASSES such as smooth brome, Bahiagrass, bluegrass, redtop, purpletop, quackgrass, broomsedge, aster, dandelion, dog fennel, goldenrod, plaintain and wild carrot.

DIRECTIONS (Cont'd)

Apply 15 to 30 lbs. per acre to control JOHNSONGRASS; use at the same rate for OTHER HAND-TO-KILL PERENNIAL WEEDS and GRASSES such as Bermudagrass, Dallisgrass, nutgrass, Vaseygrass, saltgrass, bouncingbet, dogbane, bracken fern and horsetail. Use the higher levels of the dosage ranges on adsorptive soils (usually those high in organic matter or carbon).
