FASCO GRANSIL 10P is a pelletized herbicide which contains 10% bromacii. It is designed for dry application to the soil as a spot treatment for control of willow, cottonwood, and certain other undesirable woody plants in drainage ditches.

BRUSH CONTROL

FASCO GRANSIL 10P is non-corrosive to equipment, non-volatile, and non-flammable.

Apply FASCO GRANSIL IOP as a basal treatment. Make application in spring or summer. Do not apply to brush standing in water.

BASAL TREATMENT — Spread 2 tablespoonfuls (1/2 to 1 oz.) on the ground (to cover an area 1/2 to 1 sq. ft.) at the base of each brush cluster; apply to uphill side if ground is not level. On large clumps of brush or on large trees, apply 1 tablespoonful to each of 3 or 4 spots around the base of the brush or tree.

CAUTION: Keep Out of the Reach of Children.
