DIRECTIONS FOR USE

FASCO POLYRAM-SEVIN DUST 5-5 is a specially formulated Peanut fungicide-insecticide. This product should be used in accordance with specified label directions.

PEANUTS -- Against Leadhoppers, Thrips, Velvetbean Caterpillar, Corn earworms, Armyworm, and Cercospora Leaf Spot—Apply undiluted as a dust, at the rate of 20 to 30 pounds per acre by ground dusters or airplane when insects or disease first appear. If a heavy rain occurs within twenty four hours of the first application, repeat the application within three to seven days. Otherwise repeat applications at ten to fourteen day intervals. Do not feed treated forage to dairy animals or animals being finished for slaughter.

USAGE CAUTIONS

Some phytotoxicity may occur on tender foliage in the presence of rain or high humidity of several days duration following dusting.
