FASCO Toxaphene 40-WP is a dry wettable insecticidal powder containing Toxaphene. It is a contact and stomach poison with residual action. This product is designed for use in water as a spray for control of certain insect pests as directed below.

DIRECTIONS

Use contrary to these directions may result in injury to the foliage, in unsatisfactory control, excessive residues or in other unintended consequences.

TOMATOES --- Against Leat Miners, Thrips, Armyworms, Tomato Fruitworm, Climbing Cutworms, use 5-8 lbs. per acre in 100 gallons of water when insects first appear. Repeat as needed Do not exceed 10 pounds per acre, do not apply later than 3 days before harvest.

BEANS — Against Leaf Miners, Bean Leaf Roller, and Thrips use 4-6 lbs, per acre in 100 gallons of water. Apply when insects first appear, repear as needed. Do not apply after pods begin to form. Do not exceed 10 pounds per acre. Do not feed treated vines to dairy animals or animals being finished for slaughter.

CELERY --- Against Climbing Cutworms, Fall Armyworms, Celery Looper, use 4-6 lbs. per acre in 100 gallons of water. Apply when insects first appear, repeat as needed. Do not apply after plants start to bunch or are half mature. Do not exceed 10 pounds per acre.

CABBAGE, CAULIFLOWER, BROCCOLI, LETTUCE --- Against Imported Cabbage Worms, Loopers, and Diamond Back Moth Larvae use 4-6 lbs, per acre in 100 gallons of water. Apply when insects first appear, repeat as needed. Do not exceed 10 pounds per acre for Cabbage, Cauliflower, Broccoli, or Lettuce. Do not use after head, buds, or edible parts begin forming on Broccoli, Cauliflower, Head Lettuce or Cabbage. Do not apply to leaf lettuce after the seedling stage.

CITRUS --- Against Grasshoppers, use 8 to 10 pounds per acre in 100-150 gallons of water. Apply for general outside tree coverage following disking or chopping of cover crop Do not apply within 30 days of harvest. Do not exceed 10 pounds per acre.

JURF-Against Armyworms and Sod Webworms, use 1 1/2 lbs. in 50 gallons of water to cover 5,000 Sq. Ft of lawn as needed. NOTE: Keep children and pets off treated lawns or other turf areas intil the insecticide has been washed off by sprinkling and the grass has completely dried.
