FASCO HEPTA-GRANULAR-10 is a granular insecticide containing 10% Heptachlor for application as a soil treatment against certain soil borne insects as directed below. Application can be made by ground operated dusters, with various broadcast seeders, or with certain types of fertilizer spreaders.

DIRECTIONS

Use contrary to these directions may cause serious plant, crop or personal injury, excessive residues, unsatisfactory control or other unintended consequences.

TURF (LAWNS, PARK AREAS, GOLF COURSES, CEMETER-IES, NURSERIES) — Against Ants, Chiggers, Earwigs, Fleas, Grasshoppers, Ticks, White Grubs, White-Fringed Beetle Larvae, and Japanese Beetle Larvae apply 20 pounds per acre as broadcast application. Wash into soil for control of White Grubs, White-Fringed Beetle Larvae, and Japanese Beetles Larvae. Do not graze dairy animals or animals being finished for slaughter on treated turf. Keep children and pets off treated areas until chemical is worked into the soil.

ORNAMENTAL PLANT NURSERIES:

IMPORTED FIRE ANT — Apply broadcast to the entire area using 12.5 lbs. of this product per acre. Work into the soil surface to increase the residual action. Do not apply to grazing lands. Do not use more than 12.5 lbs. of this product per acre.
