**DIRECTIONS:** Use outdoors only and only on plants listed below. Do not mix with oil. For azaleas, camellias, roses, boxwoods, gardenias, gerberas, gladiolus, poinsettias—Spray with 2 teaspoons Cygon 2E per gal. water. For camellias, apply 2 sprays 6 weeks apart first year, then annually soon after first growth in spring. As drench on camellias, drench soil around base, using 4 tablespoons Cygon 2E per gal. water per plant up to 6 ft. Increase proportionately for larger plants. For day lilies, arborvitea, euonymus, iris, juniper, oak, pine, taxus—Spray with 4 teaspoons Cygon 2E per gal. water.
