**DIRECTIONS:** For control of Brown Patch (*Rhizoctonia Solani*) attacking St. Augustine, Bermuda and similar grasses, apply 2 tablespoons per gal. of water to 30 sq. ft. (5 ft. x 6 ft.) or 1 pint in 15 to 20 gal. water to cover 500 sq. ft. (20' x 25'). For easy application, use hose-end type sprayer designed to deliver 15 to 20 gal. dilute spray while emptying qt. jar. Pour 1 pint concentrated liquid into jar and fill to top with water and apply to 500 sq. ft. Apply in spring or fall at first sign of disease and repeat in 3 to 4 weeks if necessary. Sprinkle after application to wash spray into soil surface. Follow recommended rate. Excess may cause a temporary yellowing.
