Wash hands, arms and face thoroughly with soap and water before eating or smoking. Wash all contaminated clothing with soap and hot water before re-use.

## DIRECTIONS FOR USE

For use specifically on Apple Trees as a combination insecticide and fungicide to control Apple Scab, Aphids, Mites, European Saw Fly, Bud Moth and Red Banded Leaf Roller. Apply at the rate of 40 lbs. per acre. Commence applications at the pre-pink stage and continue prior to infections during the pink calyx and cover applications. Do not apply within 21 days of harvest. If a fungicide is needed after that time switch to a straight Captan dust.
