DIRECTIONS FOR USE

ORNAMENTALS:

To control aphids and red spider. Repeat applications as necessary with thorough coverage. Injury may occur on certain ferns, including Boston Maidenhair and Pteris; also some species of Crassula.

VEGETABLES:

Potatoes - To control aphids apply at the rate of 25-30 lbs. per acre. Peas - For the control of pea aphid, make one or more applications as needed, at the rate of 25 lbs. per acre. Do not apply within 3 days of harvest. Beans - To control leafhopper and Mexican bean beetle apply at the rate of 30-35 lbs. per acre. Do not apply within 1 day of harvest. Cabbage, Cauliflower and Broccoli - For the control of aphids, imported cabbage worm and cabbage looper, apply at the rate of 30 lbs. per acre. Do not apply within 7 days of harvest. Tomatoes - For the control of aphids and spider mites on tomatoes, apply at the rate of 35-50 lbs. per acre, depending upon the degree of infestation. Do not apply within 5 days of harvest. Onions - To control onion thrip, apply at the rate of 25 lbs. per acre. Do not apply within 3 days of harvest.

POULTRY MITES: Apply to floor litter at the rate of 1 lb. of Dust to 20 square feet of floor surface. Dust roosts, droppings and nests. Do not apply Dust directly to birds. Avoid contamination of feed and water.
