Use as directed.

A general misting of the patio or picnic area when the air is quiet should be sufficient to reduce the number of annoying flies and mosquitoes during meals. If insects are congregating at any one spot, the spray should be applied directly on them. Spray as often as necessary during outdoor barbecuing or at picnics. It may be sprayed on the grill and tables, but do not spray directly on food.

**To Control Flying Insects -  
Flies, Mosquitoes, Gnats:**

Hold container upright, aim away from you, push button and spray with circular motion up toward center of room. It is not essential to hit flying insects because airborne mist will kill insects as they fly through it. Kills even DDT-resistant flies. Spray about 6 seconds for an average room (10'x10'). For HORNETS and WASPS - spray about 12 seconds. Keep windows and doors closed for 15 minutes.

**To Control Crawling Insects -  
Porchies, Ants, Silverfish:**

Spray baseboards and other surfaces where these bugs crawl, hitting as many as possible. Spray under sinks, behind appliances, openings near plumbing, and other places where these insects hide. Repeat as necessary.

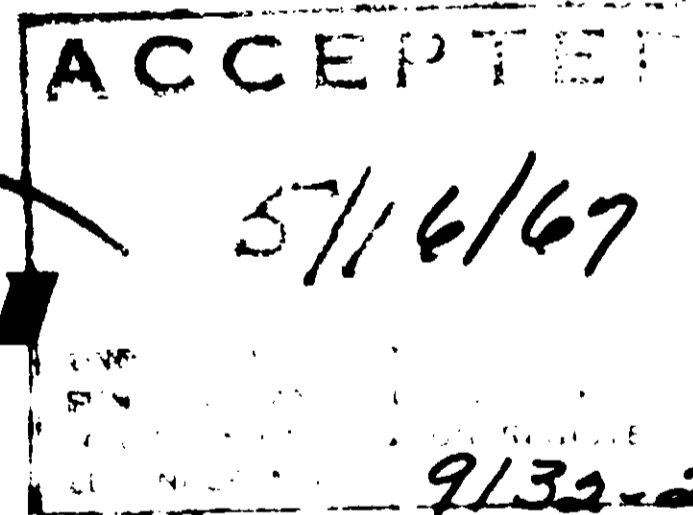
