DIRECTIONS FOR USE

Home Lawns, Turf, Nursery, and Greenhouse soils, for control of European chafer grubs, Green June Beetle larvae, Lawn Chinch bug, Japanese Beetle grubs, Sod web worms, White-fringed Beetle grubs, Wireworms, crickets. Apply 500 to 1000 pounds per acre or 12 to 24 pounds per 1000 sq.ft. of area to be treated. Apply anytime of the year that ground is not frozen. Apply just before a rain or use irrigation or sprinkler to wash material into established Turf. Do not allow children or pets on treated lawn until the insecticide is worn off the grass into the soil and the grass is completely dry.

Pre-planting Treatment: Apply at same rates as given above after broadcasting the material, disc or work into the soil to a depth of 3 to 4 inches.

Ornamental and Nursery Stock: For control of White-fringed grubs, Wireworms, Ants, Annual grubs, Cutworms, European Chafer and Larvae. For treating established Ornamentals apply 500 to 1000 pounds per acre broadcast early spring or 12 to 24 pounds per 1000 sq.ft. As a pre-planting treatment apply to prepared soil surface and work into the soil to a depth of 3 to 4 inches before planting.

PRECAUTIONS IN USING (12

Point Type)
Do not apply or allow to drift to areas occupied by human or beneficial animals. To protect fish and wildlife do not use where run-off will contaminate lakes, streams, or ponds. Use this material only for recommended purposes and at recommended dosages.
