DIRECTIONS

Use contrary to these directions may cause serious plant, crop or personal injury, excessive residues, unsatisfactory control or other unintended consequences.

COTTON — Against Boll Weevil, Cotton Bollworm, Leafworm, Fleahopper; use 10 to 20 pounds of dust per acre. Start dusting with 10 pounds per acre and increase to 12 or 15 pounds per acre tater in the season, depending on plant growth and degree of infestation. Against Grasshoppers, apply 15 to 20 pounds per acre. Do not apply over 20 pounds per acre on cotton.

NOTE: Do not graze dairy animals or animals being finished for slaughter in cotton fields that received late season treatments. Do not feed gin waste to livestock.

SOYBEANS — Against Armyworms, Bean-Leaf beetle, Blister beetle, corn earworm, Flea beetle, Grasshoppers, Green cloverworm, Velvetbean caterpillar, and Thrips; use 10 to 15 pounds per acre. Commence dusting when insects first appear and repeat as needed. Do not exceed 20 pounds per acre. Do not apply within 21 days of harvest. Do not feed treated plants or ensilage made from treated plants to poultry, dairy animals, or animals being finished for slaughter. Do not feed soybean mill trash to livestock or poultry.
