STATEMENT OF PRACTICAL TREATMENT

If Swallowed - Call a physic'an or Poison Control Center immediately.

Do not induce vomiting unless other treatment is unavailable. Emptying stomach under medical supervision
is preferred as vomiting may cause aspiration pneumonia. If necessary to induce vomiting, drink 1 to 2
glasses of water and touch back of throat with finger.
Do not induce vomiting or give anything by mouth to an
unconscious person.

If Inhaled - Remove victim to fresh air. Apply respiration if indicated.

If on Skin - Wash contaminated skin with soap and water. Launder contaminated clothing in detergent and HOT water before reuse.

If in Eyes - Flush eyes with plenty of water. Get medical attention immediately.

NOTF TO PHYSICIAN: Empty stomach if material was taken internally. Gastric lavage may be indicated. If symptoms of cholinesterase inhibition are present, atropine is antidotal. 2-PAM is also antidotal and may be administered in conjunction with atropine.

DIRECTIONS FOR USE

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal. Store in a cool, dry place. Keep from freezing. Keep cover tightly closed when not in use.

APPLICATIONS

DAIRY CATTLE: To control nornflies, stable flies, face flies and houseflies, mix 1 pint of this product with 2 gallons of water and apply 1 pint of dilute spray per adult animal no more than once per week. Apply proportionately less to smaller animals.

-OR-

Mix1pint of this product with 1 gallon of water and apply 1 to 2000 of fl. oz. per adult animal no more than once per day. Apply proportionately less to smaller animals.

To control lice and some ticks (lone star and winter), mix 1 pint of this product with 6 to 12 gallons of water and apply 1 to 2 quarts of dilute spray per adult animal no more than once per week. Apply proportionately less to smaller animals.

BEEF CATTLE: To control hornflies, stable flies, face flies, houseflies and ticks, mix I pint of this product with 6 to 12 gallons of water and apply 1 to 2 quarts of dilute spray per adult animal no more than once per week. Apply proportionately less to smaller animals.

DAIRY AND BEEF CATTLE OILERS, BACK RUBBERS OR FACE RUBBERS: To control hornflies, mix 1 pint of this product with 2 1/4 gallons of diesel oil, fuel oil or other base oil. Charge oiler or rubber as needed. Do not spray animals with oil solution.

SHEEP, GOATS, SWINE AND HORSES: To control lice and lone star or winter ticks on sheep and goats; lice on swine; lice, ticks, hornflies and stable flies on horses, mix I pint of this product with 6 to 12 gallons of water. Spray animals thoroughly applying 2 to 4 quarts of dilute spray to large animals and proportionately less to smaller animals. Repeat as needed but apply no more than once per

DAIRY AND BEEF BARNS, HOG HOUSES AND OTHER FARM BUILDINGS (EXCEPT POULTRY HOUSES): To aid in the reduction of fly populations, mix 1 pint of this product with 6 to 12 gallons of water and apply to ceilings, walls, doorways, windows or other areas where flies congregate. On refuse areas, soak surfaces with dilute spray and repeat as needed.
