FOR DOGS AND CATS

Thoroughly spray the pet's haircoat until the entire coat is wet to the skin. On a heavily coated animal, ruffle the coat and spray against the lay of the hair. For best results in controlling ticks, spray directly on the tick. Repeat treatment as necessary. This product is formulated to leave the hair coat soft and manageable for grooming.

Spray interior of kennel and other areas pet frequents, rests and sleeps, including carpeting and pet bedding. Do not spray structural surfaces where spotting, staining, or discoloration may be objectionable.

STORAGE AND DISPOSAL DIRECTIONS

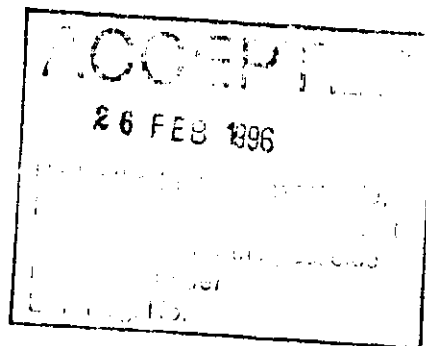
STORAGE: Protect from freezing. If frozen, allow to warm to room temperature and shake well before using. Store in closed container.
