If In Eyes

- Hold eye open and rinse slowly and gently with water for 15-20 minutes.
- Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eyes.
- Call a poison control center or doctor for treatment advice.

If Swallowed

- Call a poison control center or doctor immediately for treatment advice.
- Have person sip a glass of water if able to swallow.
- Do not induce vomiting unless told to do so by a poison control center or doctor.
- Do not give anything by mouth to an unconscious person.

If On Skin or Clothing

- Take off contaminated clothing.
- Rinse skin immediately with plenty of water for 15-20 minutes.
- Call a poison control center or doctor for treatment advice.

If Inhaled

- Move person to fresh air.
- If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible.

This product is an insecticide gel that contains an insect repellent and sunscreen. To apply, lift nozzle cap and gently squeeze bottle for easy flow of product to palm of hand or desired area then rub into coat. This product imparts a high gloss to the coat when rubbed in or brushed out leaving no other visible sign of treatment. It is especially adaptable for treating difficult areas, such as the face or ears and will not blister skin or remove or discolor hair. Avoid getting product in animal's eyes during application. Do not reapply product for 3 days.
