CAUTION: This collar is intended for use as an acaricide generator and is not to be taken internally by man or animal. Not intended for use on humans. Do not allow children to handle or play with this collar.

Harmful if absorbed through skin. Causes moderate eye irritation. Avoid contact with skin, eyes or clothing. Wash thoroughly with soap and water after handling.

Some dogs may be sensitive to this collar. Remove at first sign of irritation or adverse reaction. Do not use on sick or convalescing dogs.

Note to Veterinarian: If the dog should ingest a Preventic collar and exhibit intoxication, yohimbine by injection is antidotal.

DIRECTIONS FOR USE

It is a violation of Federal Law to use this collar in a manner inconsistent with its labeling.

Place the Preventic® collar around the dog's neck, buckle and adjust for proper fit. Cut off and dispose of excess length. The collar must be worn loosely so that two fingers may be placed between the collar and the dog's neck. If collar is worn too tightly, it may produce neck irritation. Activity against ticks starts within 24 hours and continues as long as the collar is worn (up to 120 days). Ticks present in the dog's environment that may reappear on your pet will be killed by the action of this collar. Replace collar when effectiveness diminishes. The effectiveness of the collar is not diminished by normal wetting such as rainfall, however, it is suggested that the collar be removed before bathing. Preventic is not an insecticide. Therefore, use other means for control of fleas.

DISPOSAL

Do not reuse empty pouch, box or collar. Wrap in newspaper and put in trash collection.
