CAUTION: This collar is intended for use as an insecticide and fatty acid generator and is not to be taken internally by man or animal. Not intended for use on humans. Do not allow children to handle or play with this collar.

Do not use other pesticides on dog while collar is worn. Some dogs and humans may be sensitive to this collar. Remove at first sign of irritation or adverse reaction. Do not use on sick or convalescing dogs. Do not use on puppies less than 5 months of age. Do not use more than one collar at a time on the animal.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Place the Natura® collar around the dog's neck, buckle and adjust for proper fit. Cut off and dispose of the excess length. The collar must be worn loosely so that two fingers can be placed between the collar and dog's neck. If collar is worn too tightly, it may produce neck irritation. Activity against fleas starts within 24 hours, reaches maximum effectiveness in one week and continues as long as the collar is worn (up to 150 days). Ticks are relatively harder to kill and die more slowly. Activity against ticks will occur within a few days and will continue killing and controlling ticks for up to 120 days. On long-haired dogs, aids in control of ticks. Fleas and ticks present in the animal's environment that may reappear on the dog will be killed and controlled by the action of the collar. Replace collar when effectiveness diminishes. Collar is not affected by normal wetting such as rainfall; however, it is suggested the collar be removed before bathing.

DISPOSAL

Do not reuse empty pouch, box or collar. Wrap in newspaper and put in trash collection.
