In order to protect health and the environment, the Administrator, on his motion, may at any time suspend or cancel the registration of a pesticide in accordance with the Act. The acceptance of any name in connection with the registration of a product under this Act is not to be construed as giving the registrant a right to exclusive use of the name or to its use if it has been covered by others.

This product is conditionally registered in accordance with FIFRA sec. 3(c)(7)(A) provided that you:

1. Submit/cite all data required for registration/reregistration of your product under FIFRA section 3(c)(5) when the Agency requires all registrants of similar products to submit such data; and submit acceptable responses required for reregistration of your product under FIFRA section 4.

2. Make the labeling changes listed below before you release the product for shipment:

- a. Add the phrase, "EPA Registration No. 2382-108".
- b. Revise the Hazards to Human and Domestic Animals as follows:

HUMAN: Harmful if inhaled. Avoid breathing dust. Remove contaminated clothing and wash before reuse. Wash thoroughly with soap and water after handling.

ANIMALS: Do not use on puppies less than six months of age. Do not use on old, sick or debilitated animals.

- c. Add the heading **STATEMENT OF PRACTICAL TREATMENT** above the IF INHALED statement and then revise as follows:

IF INHALED: Remove victim to fresh air. If not breathing, give artificial respiration preferably mouth-to-mouth. Get medical attention.

- d. On the front panel delete "**Acaricide**". The correct description for the pests listed is **Insecticide Powder**.
- e. The application rate of 1/3 an oz per 20 lbs of body weight of dog, although accurate, is not very helpful to the consumer, who might not have a good understanding of 1/3 oz of product. Therefore we recommend this product be packaged with a measuring device that dispenses just enough for a typical dog.

3. Submit five copies of your final printed labeling before you release the product for shipment. Refer to the A-79 Enclosure for a further description of final printed labeling.

4. The Confidential Statement of Formula (CSF) dated February 1, 1993 will not meet the label claim for the nominal concentration. Our records indicated that the source product from both suppliers is 92% pure rather than 93% as you reported. Therefore the nominal concentration must be calculated based on 92% purity. Please revise the CSF.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

A stamped copy of the label is enclosed for your records.

DIRECTIONS FOR USE

Apply powder at a rate of 1/3 oz. per 20 lb. body weight by sprinkling from dispenser over entire body surface. For best penetration of hair coat, ruffle hair while applying. Apply carefully to head and face avoiding contact with animal's eyes and nose. Apply directly to attached ticks. Reapply as needed. Reapply after bathing or exposure to heavy rain.

STORAGE AND DISPOSAL

STORAGE: Store in a closed container, in a cool, dry area, and out of reach of children.

DISPOSAL: Do not re-use empty container. Wrap container in newspaper and discard in trash.
