It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Aqua-Pel Fly Repellent Spray is especially designed to protect horses and ponies from biting and nuisance flies, such as stable flies, horn flies, horse flies, deer flies, face flies, house flies, mosquitoes and gnats. Shake well and rotate nozzle 1/4 turn to spray position and squeeze trigger to initiate a fine mist spray. (Close nozzle after use to avoid loss of product). Spray at a distance of 6 to 12 Inches by squeezing trigger repeatedly and rapidity.

Aqua-Pel Fly Repetient Spray should be sprayed liberally over the horse's coat, especially on areas that biting and nuisance flies favor. Do not spray into eyes, nostrits or on genitalia. For application to these areas, apply to towelling or a sponge and wipe on. Repeat application as needed.
