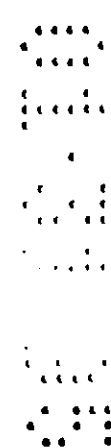

PRECAUTIONARY STATEMENTS
HAZARDS TO HUMANS AND DOMESTIC ANIMALS

CAUTION: This collar is intended for use as an insecticide generator and is not to be taken internally by man or animal. Not intended for use on humans. The insecticide in this collar is a cholinesterase inhibitor. Do not allow children to handle or play with this collar.

Note to Physician/Veterinarian: This product contains a cholinesterase inhibitor. Atropine sulfate is antidotal only if signs of cholinesterase inhibition are present.

Do not use dogs that are pregnant, nursing, less than six months old, or sick or convalescing. Remove collar and shampoo dog if skin irritation, salivation, loose stool, depression or tremors are observed. Do not use other cholinesterase-inhibiting pesticides, drugs or chemicals on dog while collar is worn.

DIRECTIONS FOR USE

It is a violation of Federal Law to use this collar in a manner inconsistent with its labeling.

Place PARASITEX® collar around the dog's neck, adjust for proper fit and buckle in place. Cut off and dispose of excess length. The collar must be worn lightly enough to contact the skin and to prevent the dog from removing it. If collar is worn too tightly, it may produce neck irritation. Activity against fleas and ticks (*Rhipicephalus sanguineus*, i.e., Brown Dog Tick, and *Ixodes sp.*) starts within 24 hours, reaches maximum effectiveness on the second day and continues as long as the collar is worn (up to 150 days). Fleas and ticks present in the animal's environment that may reappear on the dog will be killed and controlled by the action of the collar. Replace collar when effectiveness diminishes. Collar is not affected by normal wetting such as rainfall; however, it is suggested the collar be removed before bathing.

DISPOSAL

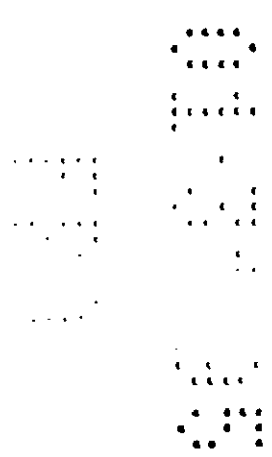
Do not reuse empty pouch or box. . Wrap pouch or box and put in trash collection. When discarding used collar, wrap in newspaper and place in trash collection.

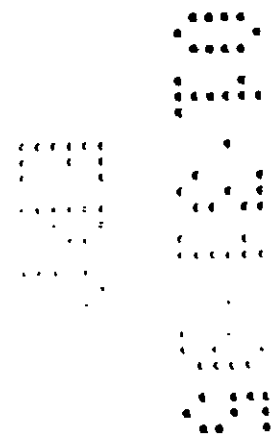
