In accordance with 40 CFR 152.46, Virbac AH, Inc. submits herewith an application for pesticide notification for subject product. This submission allows for labeling changes per PR Notice 2007-4 to the side/back panel of the label. The labeling changes are noted below and clearly marked on the revised product label (see attachment).

"Notification of label change per PR Notice 2007-4. This notification is consistent with the guidance in PR Notice 2007-4 and the requirements of EPA's regulations at 40 CFR §§ 156.10, 156.140, 156.144, 156.146, and 156.156. No other changes have been made to the labeling or the Confidential Statement of Formula for this product. I understand that it is a violation of 18 U.S.C.
