**DIRECTIONS FOR USE:** It is a violation of Federal Law to use this product in a manner inconsistent with its labelling.

Spray the animal until the entire coat is wet (dosage approximately 5 g/kg on cats, 7.5 g/kg on dogs, depending on density and length of haircoat). On heavily coated animal, ruffle the coat and spray against the lay of the hair. This bottle contains sufficient spray, when applied at the recommended rate, for 5 applications to a 25lb. dog or 20 applications to a 10 lb. cat. When applied at the label dose rate, the pet should not be retreated more frequently than once each 14 days. Lighter applications will reduce period of effectiveness, may result in earlier reinfection and may require more frequent retreatment. For best results in controlling ticks, spray directly on the tick.

**STERILIZES** - Fleas on cats and dogs for up to 45 days and breaks the flea life cycle.

**FLUSHES AND KILLS IMMEDIATELY** - Fleas.

**KILLS RESIDUALLY** - Ticks, Fleas, Lice up to 10 days.

**REPELS** - Mosquitoes, Fleas, Gnats and Flies

**DEODORIZES** - Imparts a pleasing residual aroma.
