DIRECTIONS FOR USE: It is a violation of Federal law to use this product in a manner inconsistent with its labelling. Spray over entire haircoat making sure the coat is thoroughly wetted to the skin. Spray against the lay of the hair, ruffling the coat on long-haired pets. Weight of pet, length of hair and density of coat will determine amount of spray to be applied to wet the skin (average dose approximately 7.5 g/kg for dogs and 5g/kg for cats).
