The Insect growth regulator (a synthetic flea hormone), pyriproxifen, sterilizes all fleas that jump onto the pet (even new fleas before they start laying eggs) and therefore kills all flea eggs. Pyriproxyfen is adsorbed onto, and sticks tightly to hair and skin, even after complete rinsing, to provide 8 weeks of continuous flea ovisterilant efficacy. This breaks the flea's life cycle by preventing the development of new fleas in the pet's environment and the build-up of reinfestation pressure. This shampoo is therefore designed primarily for routine, year-round bathing of pets that may, at some time, be exposed to a flea infested environment. As a flea control measure, it works best when routine treatment is started before the flea season, or in a presently flea-free environment.
